Re: Downtown CID Board of Directors – Annual Membership & Resignation

Executive Summary

The Downtown Community Improvement District (CID) Board of Directors has submitted a slate of proposed Board of Director members to the Mayor for consideration for appointment.

Discussion

The Downtown CID was established by ordinance on February 7, 2011, and it provided for a minimum of nine members on the Board of Directors, with the composition of the initial board consisting of fifteen members. The initial fifteen members were appointed by the ordinance establishing the Downtown CID to staggering terms of one, two, and three years.

The qualifications to serve on the Board of Directors are set out in the Downtown CID petition and state law. It is required that each director be at least 18 years of age and be either an owner of real property within the District, an owner of a business operating within the District, or a registered voter residing in the District, all as defined in the CID Action (Section 67.1401 RSMo. et seq.).

The petition governing the formation of the Downtown CID provides a process for nomination and approval of members to the Board of Directors whereas upon submission of a slate of successor directors by the Downtown CID to the Mayor, the Mayor (with the

consent of the City Council) shall approve the appointments or request alternates be submitted by the Downtown CID Board of Directors. The approval or request for alternates is required to occur within 30 days of submission of names by the Downtown CID.

If there is a request for alternative names, the Downtown CID Board of Directors shall resubmit the slate with alternates, and the Mayor shall choose appointees from the names submitted and seek the consent of the City Council. The City Council can accept or refuse consent of the slate submitted by the Mayor. If the City Council refuses to consent to the slate, within ten days, the Mayor shall request alternatives from the Downtown CID Board of Directors.

The Downtown CID submitted a slate of five candidates on November 15, 2023 to be appointed for terms beginning February 7, 2024 and ending February 6, 2027, and that slate includes Aric Jarvis, Kathleen Murphy, Kenny Greene, Jesse Slade, and Jamie Varvaro.

In addition, due to a resignation, the Downtown CID submitted the name of another candidate to be appointed to a term beginning now and ending February 6, 2025, and that candidate is Tootie Burns.
