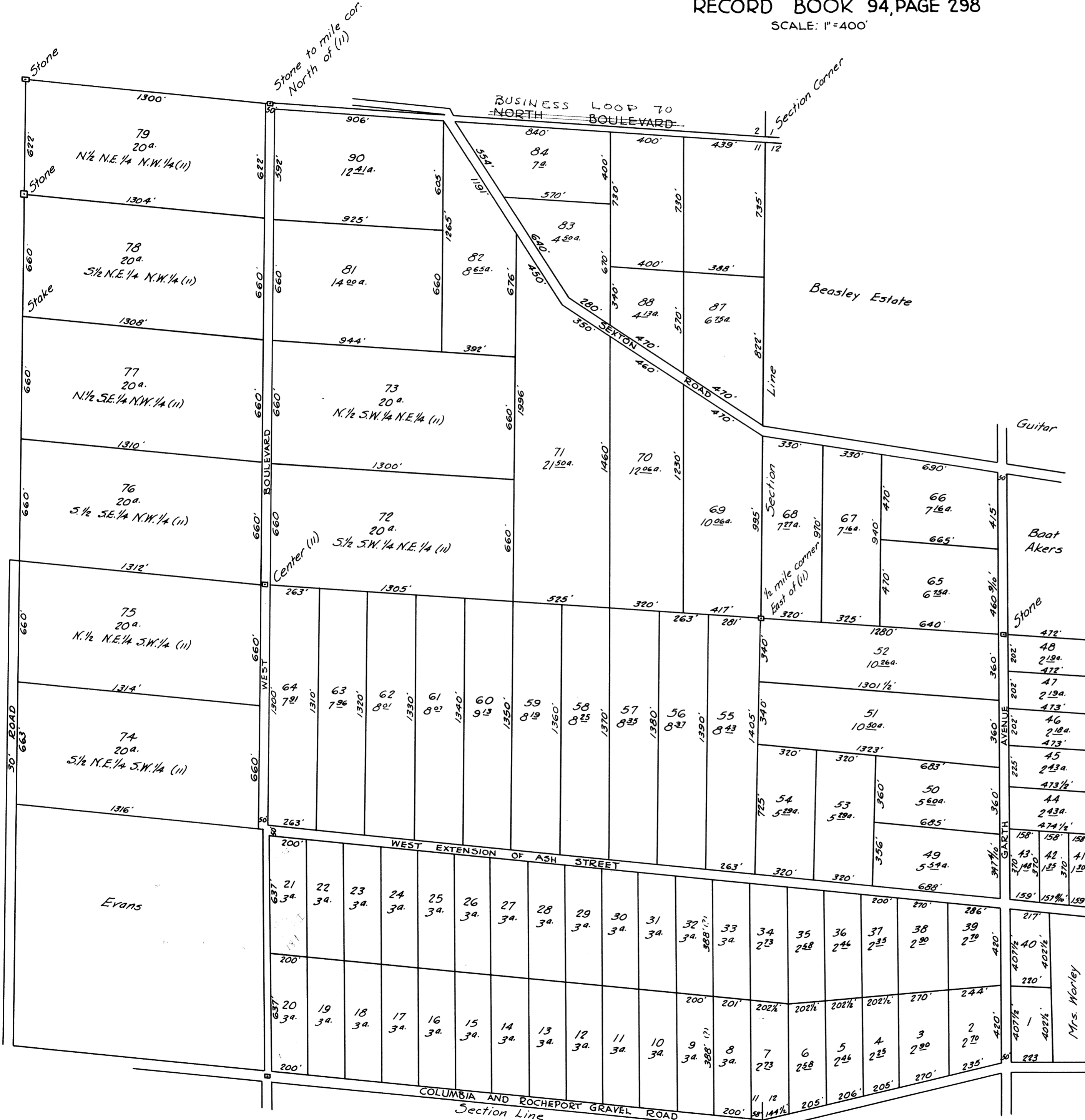


GARTH'S ADDITION TO COLUMBIA
