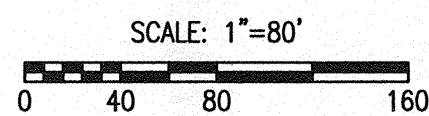


LOCATION MAP

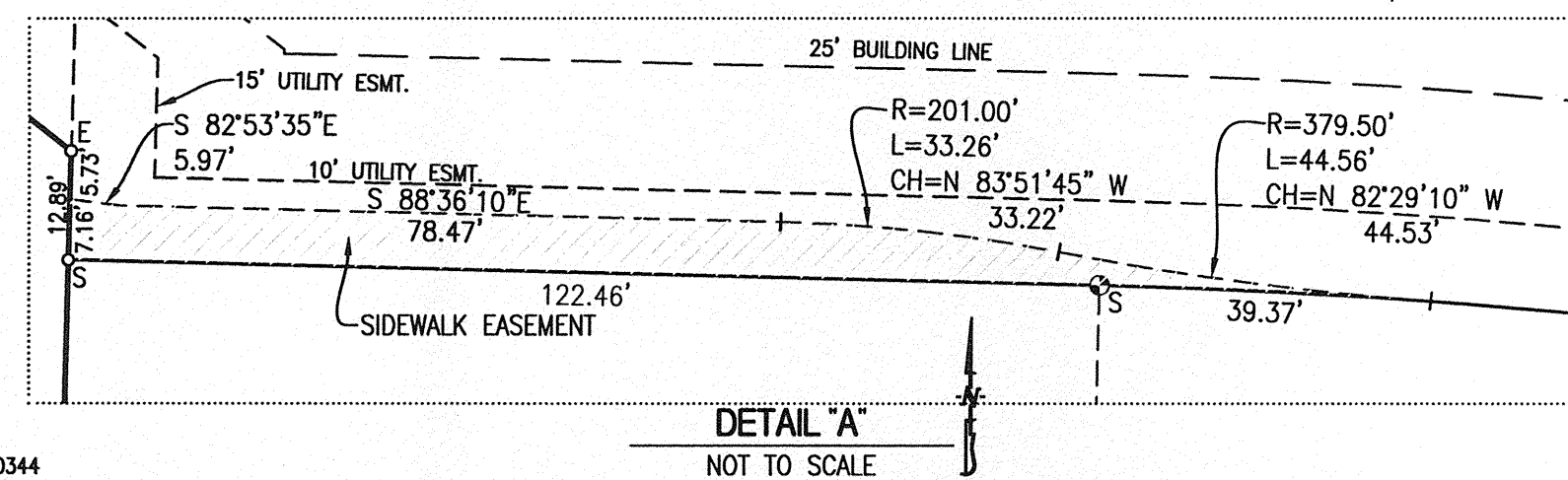

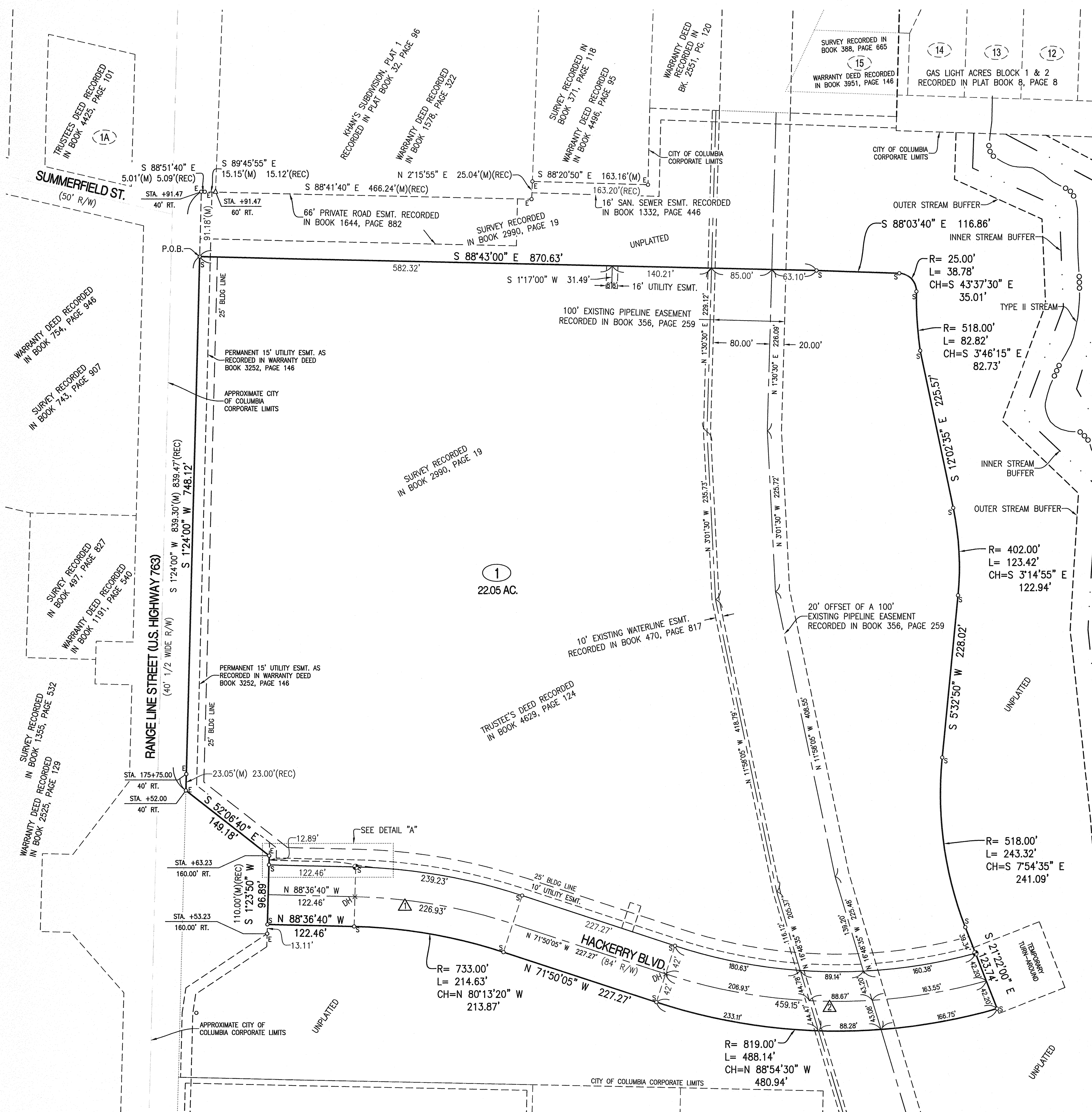

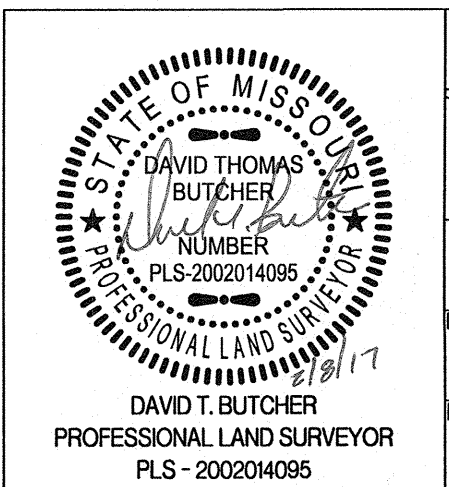
