# PLANNING AND ZONING COMMISSION MEETING COLUMBIA CITY HALL COUNCIL CHAMBER 701 EAST BROADWAY, COLUMBIA, MO July 10, 2025

### Case Number 219-2025

A request by Allstate Consultants LLC (agent), on behalf of Bethel Baptist Church, Inc. Rt. 3, Columbia, MO 65201 (Owner), for approval of a two-lot final minor plat of a 7.85-acre property, to be known as "Bethel Baptist Church Plat 1". The subject site is zoned R-2 (Two-Family Dwelling) and is located at 201 Old Plank Road.

MS. GEUEA JONES: May we please have a staff report?

Staff report was given by Mr. Rusty Palmer of the Planning and Development Department. Staff recommends approval of the final plat entitled "Bethel Baptist Church Plat 1," subject to minor technical corrections.

MS. GEUEA JONES: Thank you. Before we go to questions for staff, if any of my fellow Commissioners have had contact with parties to this case outside of a public hearing, please disclose so now. Seeing none. Are there any questions for staff? Seeing none. We will go to public comment.
