

Introduced by Buffalo Council Bill No. R 131-22A

A RESOLUTION

amending and restating Resolution No. 113-22 that granted temporary waivers from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages and Section 16-258 of the City Code to allow amplified sound exceeding a distance of 100 feet for one (1) music event hosted by My House located at 119 S. Seventh Street.

WHEREAS, on August 1, 2022 the City passed Resolution No. 113-22 that granted temporary waivers from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages and Section 16-258 of the City Code to allow amplified sound exceeding a distance of 100 feet for three (3) music events hosted by My House located at 119 S. Seventh Street; and

WHEREAS, the event organizer, Rader Hospitality, LLC, has requested that the event date of August 22, 2022 be removed from the resolution and a new date of October 12, 2022 be added to the resolution; and

WHEREAS, the City Council finds it to be in the best interest of the citizens of Columbia to amend and restate Resolution No. 113-22 to accurately describe the dates of the music events.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Resolution No. 113-22 is hereby amended and restated to grant temporary waivers from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages and Section 16-258 of the City Code to allow amplified sound exceeding a distance of 100 feet for three (3) music events hosted by My House located at 119 S. BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Contingent upon approval of a street closure permit, the The City Council hereby grants temporary waivers from the requirements of Section 16-185 of the City Code so that the possession of an open container of alcohol and consumption of an alcoholic beverage, and Section 16-258 of the City Code to allow amplified sound exceeding a distance of 100 feet, shall be allowed for the area along the alleyway between Sixth Street and Seventh Street during three (3) music events hosted by My House located at 119 S. Seventh Street on the following dates and times:

1. ~~August 22, 2022 – 5:00 p.m. to 11:59 p.m.~~
2. September 7, 2022 – 5:00 p.m. to 11:59 p.m.
3. ~~September 28, 2022 – 5:00 p.m. to 11:59 p.m.~~
3. October 12, 2022 – 5:00 p.m. to 11:59 p.m.


