I. INTRODUCTORY ITEMS

The City Council of the City of Columbia, Missouri met for a regular meeting at 7:00 p.m. on Monday, November 7, 2022, in the Council Chamber of the City of Columbia, Missouri. The Pledge of Allegiance was recited, and the roll was taken with the following results: Council Member BETSY PETERS, Mayor BARBARA BUFFALOE, Council Member PAT FOWLER, Council Member ANDREA WANER, Council Member ROY LOVELADY, Council Member NICK FOSTER, and Council Member MATT PITZER were present. City Manager De'Carlton Seewood, City Counselor Nancy Thompson, City Clerk Sheela Amin, and various Department Heads and staff members were also present.

Chriss Jones, a Second Ward resident, spoke regarding the Citizens Police Review Board.

Barbara Jefferson, a First Ward resident, spoke about various topics to include input from neighborhood associations due to some being inactive, the status of ARPA money, and the BeHeardCoMo platform.

Eugene Elkin, 3406 Range Line Street, spoke about various topics to include him having difficulty hearing speakers at council meetings, a request for ARPA funding statuses at council meetings, Room at the Inn and transportation to the facility, lack of participation at council meetings, and the fact trash bags were not discussed.

The Council and staff discussed various topics to include potentially canceling the July 3, 2023 Council Meeting, the fact that the November 21, 2022 Pre-Council Meeting would include the onboarding and training of the Citizens Police Review Board (CPRB) members, the potential of a work session on November 28, 2022 to discuss improvements to the Water Treatment Plant, a recitation of the ARPA grants the City has or plans to apply for, the temperature threshold at which warming centers are opened, a potential process for crime prevention through environmental design (CPTED), the future of the CPRB and a potential facilitator to assist with that discussion, the fact the Council had received informative staff reports on various pre-council and regular meeting topics allowing for productive conversations and the desire for that to continue, the response of MoDOT to the City's letter regarding the I-70 corridor to include the Hwy 63/I-70 interchange, and information regarding what might need to happen to start the project moving in relation to a potential interchange at Scott Boulevard.
