Re: Amending Chapter 14 relating to Removal of On-Street Parking on Tiger Avenue

### **Executive Summary**

Amending Sections 14.324 (Parking Prohibited) and 14.414.1 (Five-hour zones) of the City Code related to the removal of on-street parking on the east side of Tiger Avenue from Rollins Street to 150 feet north of Kentucky Avenue.

#### Discussion

At the July 17, 2017 council meeting, staff prepared a report for Council concerning a request received from the University of Missouri Vice Chancellor's office to remove on-street parking on the east side of Tiger Avenue from Rollins Street to 150' north of Kentucky Avenue in an effort to reduce traffic congestion on campus. Council directed staff to remove the on-street parking on the east side of Tiger Avenue, as well as stripe bicycle lanes on the east and west sides of the street (see attached Tiger Marking Plan) for a one year period. Staff is in the process of making these changes which will be completed prior to the beginning of the University's fall semester. Staff has drafted legislation amending Chapter 14, Sections 324 (Parking Prohibited) and 414.1 (Five-hour zones) of the City Code to reflect these changes.

Thirty-seven parking meters will be removed from Tiger Avenue resulting in a loss of revenue (parking meters and citations) of \$66,374 for a one year period. Staff will bring forward legislation authorizing an MOU with the University for the reimbursement of \$66,374 for this trial period. Staff will continue to evaluate bicycle and pedestrian counts over the next year and report back to council.

### Fiscal Impact

Short-Term Impact: The loss of revenue for one year is estimated at \$66,374, which will be reimbursed by the University of Missouri.
