Re: Authorize an Agreement with Missouri Highways and Transportation Commission (MHTC) to relinquish a portion of the state highway to the Columbia Regional Airport upon opening

the new Route H.

### **Executive Summary**

Approve and authorize the City Manager to sign the road relinquishment agreement with the Missouri Highways and Transportation Commission (MHTC). Columbia Regional Airport will assume responsibility for the existing portion of Route H and the Commission will accept the newly constructed Route H in the state system upon completion of the work.

#### Discussion

The current location of Route H will be in conflict with the new runway protection zone of the 900' extension of Runway 2-20. In order to begin construction on the extension, Route H must be relocated. Once the construction is complete, the Columbia Regional Airport will assume the responsibilities of the old portion of Route H and the Missouri Highways and Transportation Commission will assume responsibility of the new section of Route H once it is completed and open to traffic.
