**AN ORDINANCE**

amending Chapter 17 of the City Code to establish fees for the use of the cross country course and associated amenities at the Gans Creek Recreation Area; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 17 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 17-161. Fees.

The following parks and recreation fees are hereby established:

(o) Gans Creek Recreation Area. For use of the running course, parking lot(s), finish line and athlete and indoor pavilions, the following fees are hereby established.

Course Fees

Dedicated course fee/athlete pavilion..... \$1,300.00

Dedicated course fee/athlete pavilion and indoor pavilion ..... 1,500.00

Fees, per participant:

0-100 participants ..... \$2.40

101-200 participants ..... 2.04

201-300 participants ..... 1.80

301-400 participants ..... 1.56

401-500 participants ..... 1.20

Over 500 participants..... 1.00

Portable toilet, per unit fee\*

<u>Standard</u> .....	<u>\$60.00</u>
<u>Wheelchair accessible</u> .....	<u>70.00</u>

Event Fees

<u>Non-refundable race deposit**</u> .....	<u>\$300.00</u>
<u>Gate fee – minimum***</u> .....	<u>100.00</u>
<u>Non-food vendor fee, per day</u> .....	<u>50.00</u>

\*Rental of portable toilets will be required for races with more than two hundred (200) participants. The number of participants determine the number of portable toilets required to be rented.

\*\*Applied to final rental fee if tournament is held.

\*\*\*One hundred dollar (\$100.00) minimum or one dollar (\$1.00) per ticket sold, whichever is greater.

(e-p) All revenues derived from the fees set forth in subsections (a) through (m) shall become a part of the recreation services fund of the city unless otherwise specified.


(p-g) *Recreation facility use charge.*
