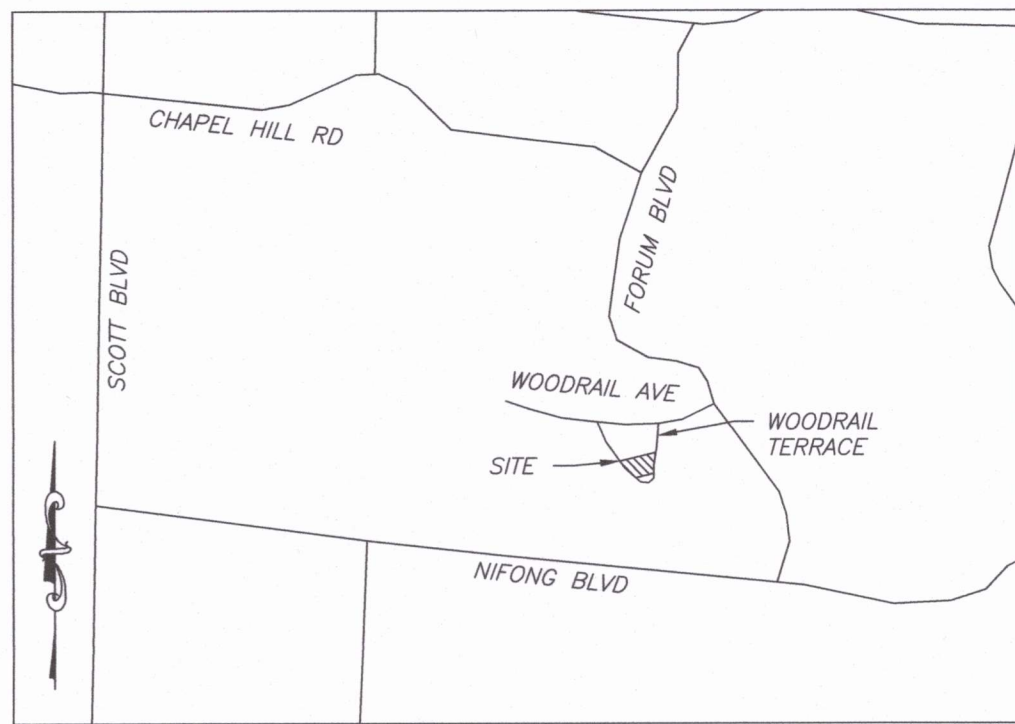

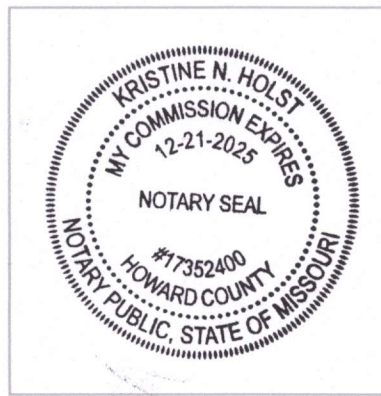

PROPERTY DESCRIPTION

TWO TRACTS OF LAND LOCATED IN THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 27, TOWNSHIP 48 NORTH, RANGE 13 WEST, AND IN THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 26, TOWNSHIP 48 NORTH, RANGE 13 WEST, BOONE COUNTY MISSOURI, AND BEING SHOWN AS LOTS 14B AND 14C OF A REPLAT OF LOT 14 OF WOODRAIL PLAT NO. 3 RECORDED IN PLAT BOOK 35, PAGE 60, ALL BEING OF THE BOONE COUNTY RECORDS AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF SAID TRACT 14C, ALSO BEING A POINT ON THE WEST RIGHT-OF-WAY LINE OF WOODRAIL TERRACE; THENCE SOUTH ALONG SAID WEST RIGHT-OF-WAY LINE BEING A CURVE TO THE LEFT HAVING A RADIUS OF 593.96 FEET, AN ARC LENGTH OF 59.27 FEET, AND SAID CURVE HAVING A CHORD WHICH BEARS S 05°34'55" E, 59.25 FEET; THENCE S 08°26'25" E, 52.41 FEET TO THE SOUTHEAST CORNER OF SAID LOT 14C; THENCE LEAVING SAID WEST RIGHT-OF-WAY LINE, WEST ALONG THE SOUTH LINE OF SAID LOTS 14B & 14C S 74°29'05" W, 110.53 FEET; THENCE S 15°31'20" E, 15.55 FEET; THENCE S 74°28'40" W, 75.33 FEET TO THE SOUTHWEST CORNER OF SAID LOT 14B, ALSO BEING A POINT ON THE EAST RIGHT-OF-WAY LINE OF WOODRAIL TERRACE; THENCE LEAVING SAID SOUTH LINE NORTH ALONG SAID EAST RIGHT-OF-WAY LINE N 22°28'25" W, 2.25 FEET; THENCE ALONG A TANGENT CURVE TO THE LEFT HAVING A RADIUS OF 593.97 FEET, AN ARC LENGTH OF 127.17 FEET, AND SAID CURVE HAVING A CHORD WHICH BEARS N 28°36'20" W, 126.90 FEET TO THE NORTHWEST CORNER OF SAID LOT 14B; THENCE LEAVING SAID EAST RIGHT-OF-WAY LINE EAST ALONG THE NORTH LINE OF SAID TRACTS 14B & 14C, N 74°27'40" E, 231.56 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.55 ACRES.
