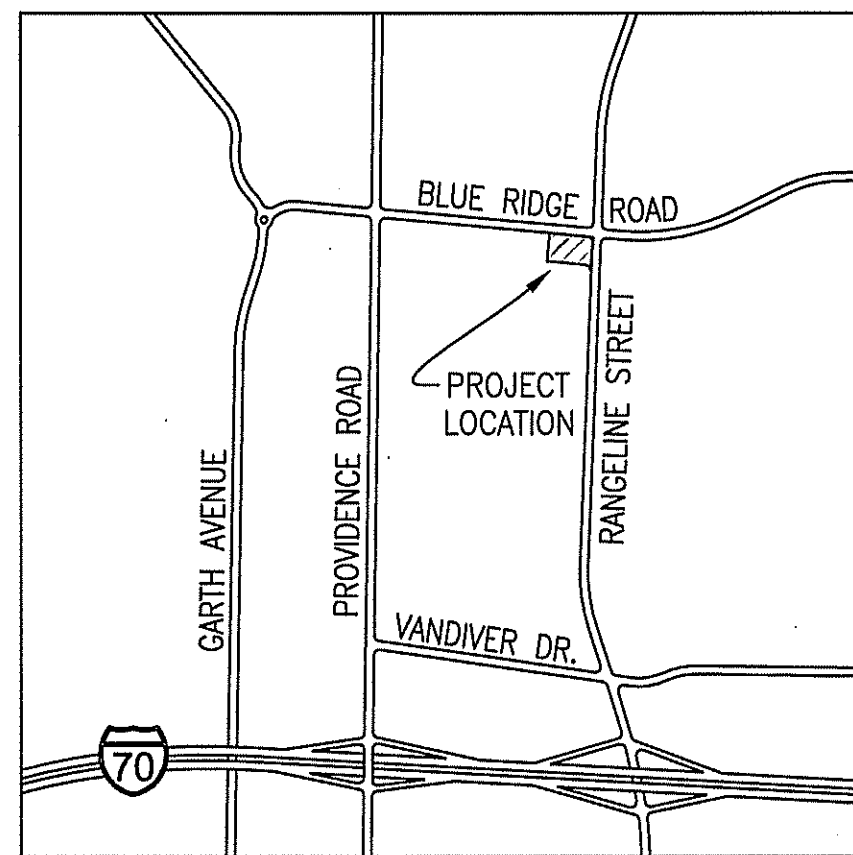
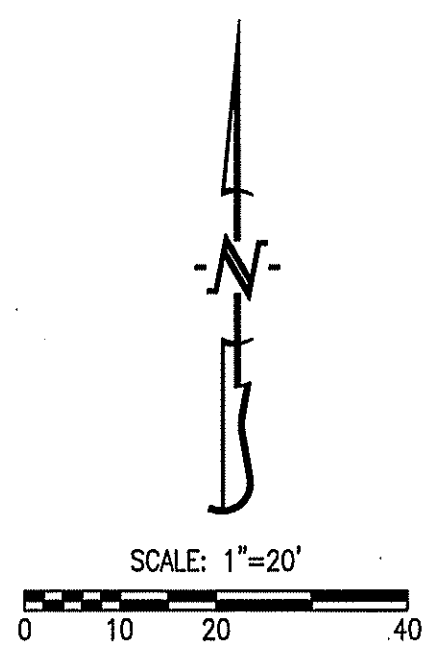


FINAL PLAT BLUE RIDGE TOWN CENTRE, PLAT No. 2

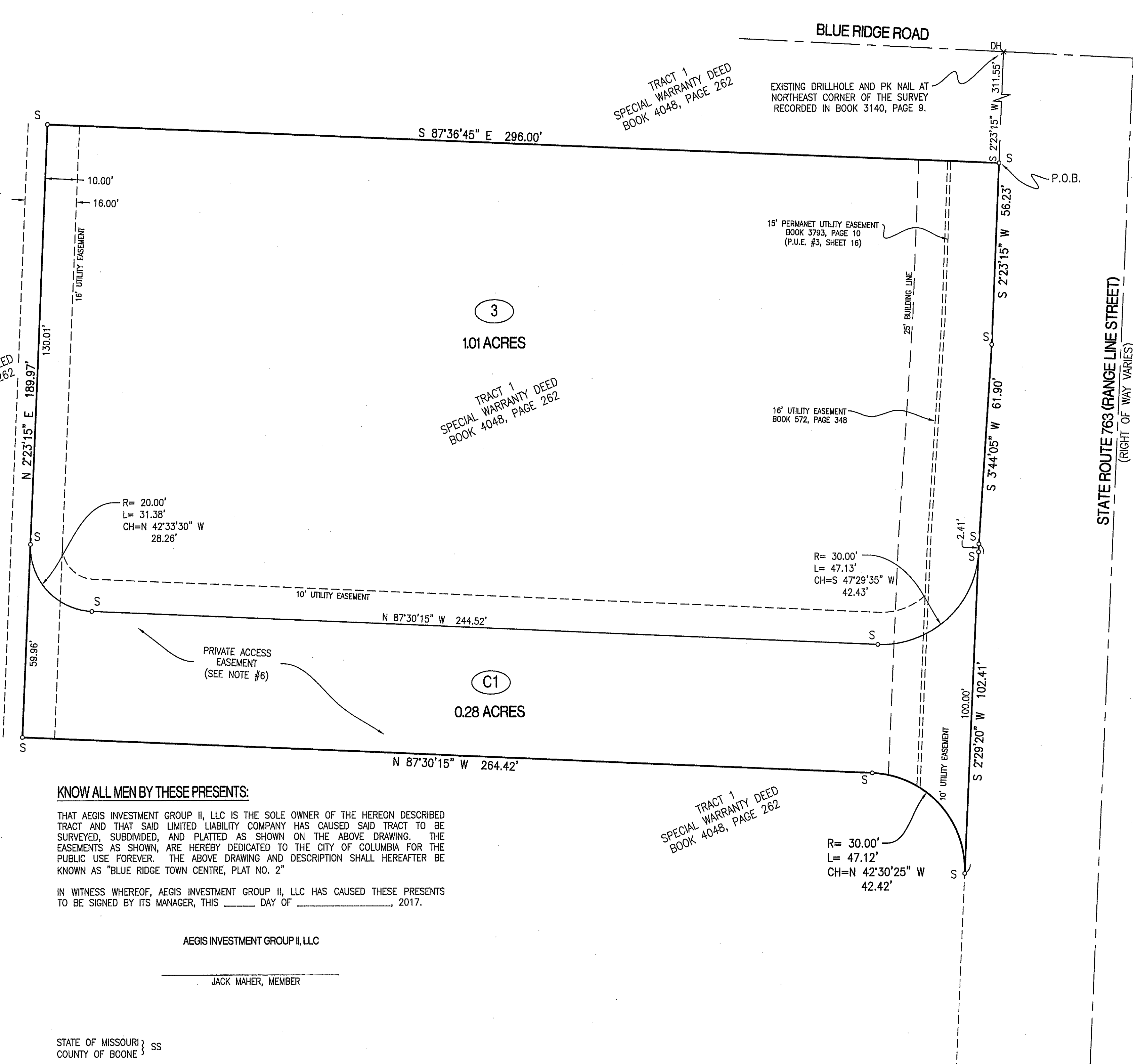


LOCATION MAP

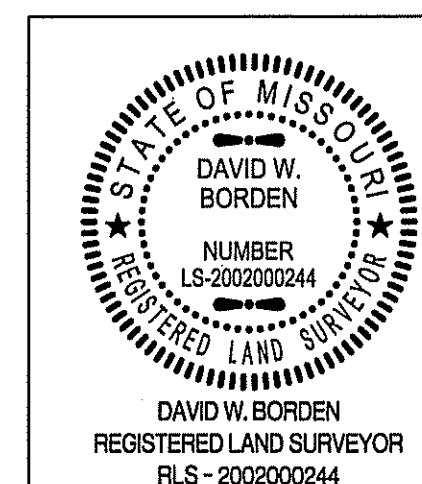
