OBSERVATIONS ABOUT 2019 ORGANIZATIONAL RATINGS: 1) COMMISSIONERS ARE GENERALLY CONSISTENT IN THEIR RATINGS OF ALL 10 ORGANIZATIONAL DIMENSIONS FOR AGENCIES SUBMITTING COMPLIANT PROPOSALS. BUT, WHEN PROPOSALS ARE INCOMPLETE OR NON-RESPONSIVE, COMMISSIONERS' RATINGS ACROSS THE 10 DIMENSIONS PREDICTABLY SHOW MORE VARIATION. (SEE CELLS HIGHLIGHTED IN YELLOW.) 2) COMMISSIONERS ARE THE LEAST CONSISTENT IN ASSIGNING RATINGS TO TWO ORGANIZATIONAL FINANCIAL DIMENSIONS: #1 ("No Significant Issues Identified in Financial Statement") AND #5 ("Sufficient Level of Reserve Funds"). (SEE CELLS HIGHLIGHTED IN ORANGE.) THUS, STAFF MAY WANT TO PROVIDE COMMISSIONERS WITH MORE SUPPORT AROUND THESE TWO DIMENSIONS.
