Re: Approval of a Real Estate Contract for purchase of a portion of the property at 2510 Vandiver Drive and lot 501 of Mid-Missouri Industrial Park Plat 5 to be used to construct a

stormwater detention facility.

Executive Summary

This resolution would authorize the City Manager to sign a contract to purchase the two properties described as follows: Lot Five Hundred One (501) of Mid-Missouri Industrial Park Plat Five (5) in the City of Columbia, Boone County, Missouri, to be used to construct a regional stormwater detention basin, which will reduce the occurrence of flooding downstream and provide water quality improvement for the Hinkson Creek watershed.

Discussion

Little Dixie/Deer Park Investment Company, L.L.C. has indicated a willingness to sell the existing property located at Lot Five Hundred One (501) of Mid-Missouri Industrial Park Plat Five (5) in the City of Columbia, Boone County, Missouri, as shown by the Administrative Plat thereof recorded in Book 3385, Page 136, Records of Boone County, Missouri and property on 2510 Vandiver Drive (being adjacent to Lot 501 and being part of parcel 17-107-00-04-017.00 01) to the City. See attached diagram.

The purchase price for all property is \$172,524.00, which is consistent with the appraised values performed by Moore & Shryock Real Estate Appraisers and Consultants on March 28, 2024. The contract provides for closing to occur on or before March 31, 2025.

The Calvert Drive Stormwater Improvement Project is approved for \$2,219,928.00 in reimbursement from the American Rescue Plan Act (ARPA). The acquisition of the lots is critical to the Calvert Drive Stormwater Improvement Project. The land will be used to construct a regional stormwater detention basin, which will reduce the occurrence of flooding downstream and provide water quality improvement for the Hinkson Creek watershed. Providing water quality in the Hinkson watershed aligns with the Hinkson Creek Collaborative Adaptive Management goals.
