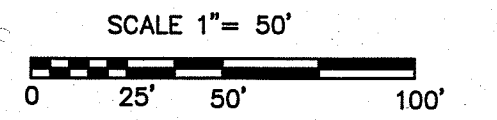
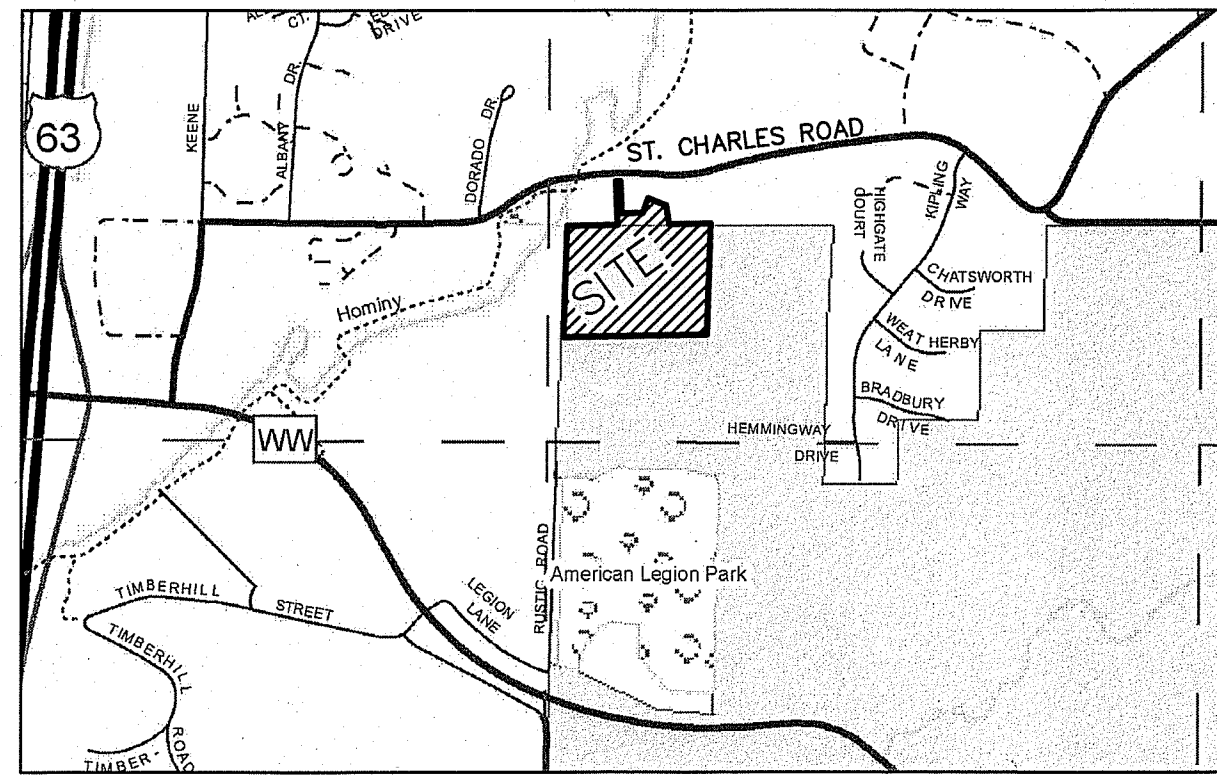

**DESCRIPTION**  
A TRACT LOCATED IN THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 16, AND THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 9, ALL IN TOWNSHIP 48 NORTH, RANGE 12 WEST, CITY OF COLUMBIA, BOONE COUNTY, MISSOURI, AND BEING THE TRACT DESCRIBED BY THE DEED IN BOOK 4696 PAGE 90 AND THE DEED IN BOOK 4696 PAGE 92, ALSO BEING ALL OF THE TRACT SHOWN BY SURVEY IN BOOK 279 PAGE 389 AND LOT 4 OF TEREBINTHS SUBDIVISION PLAT 1 AS SHOWN IN PLAT BOOK 28 PAGE 71 ALL OF THE BOONE COUNTY RECORDS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID SECTION 16, AS SHOWN BY SURVEY IN BOOK 448 PAGE 396 AND SURVEY IN BOOK 364 PAGE 45 BOTH OF THE BOONE COUNTY RECORDS. THENCE WITH THE LINES OF THE TRACTS SHOWN BY SAID SURVEY IN BOOK 279 AND PAGE 389 AND SAID LOT 4 N 89°02'00" E, 262.50 FEET; THENCE N 02°24'45" W, 227.10 FEET WITH A NON-TANGENT CURVE TO THE RIGHT, CURVE RADIUS OF 850.59 FEET, CHORD N 88°23'15" E, 25.00 FEET; THENCE S 02°24'45" E, 167.35 FEET; THENCE N 89°02'00" E, 107.44 FEET; THENCE N 21°06'00" E, 82.11 FEET; THENCE S 68°54'00" E, 100.00 FEET; THENCE S 08°30'30" E, 99.40 FEET; THENCE N 89°02'00" E, 216.20 FEET; THENCE S 01°51'15" W, 584.10 FEET; THENCE S 89°02'00" W, 746.20 FEET; THENCE N 01°51'15" E, 584.10 FEET TO THE POINT OF BEGINNING AND CONTAINING 10.60 ACRES.

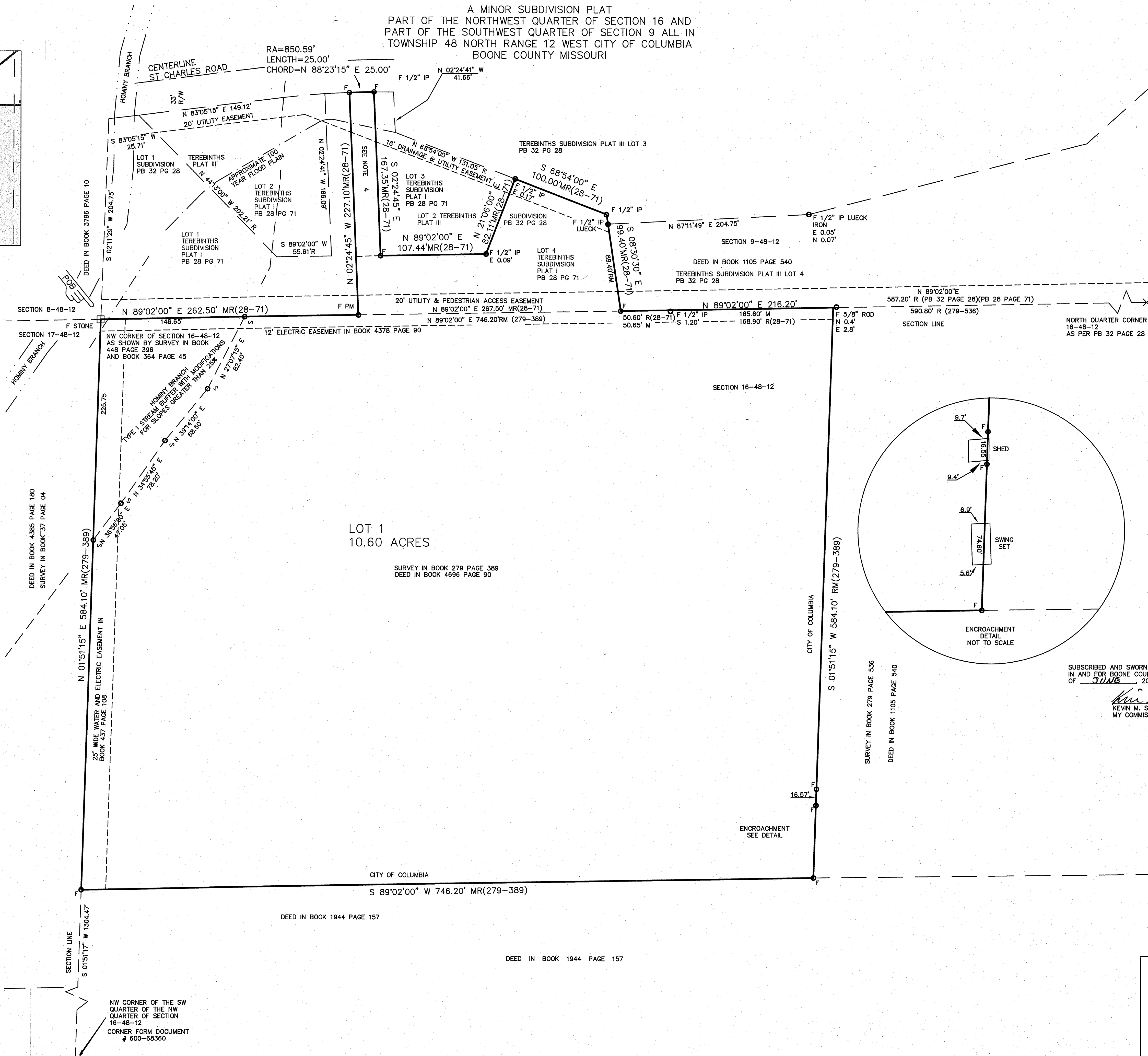

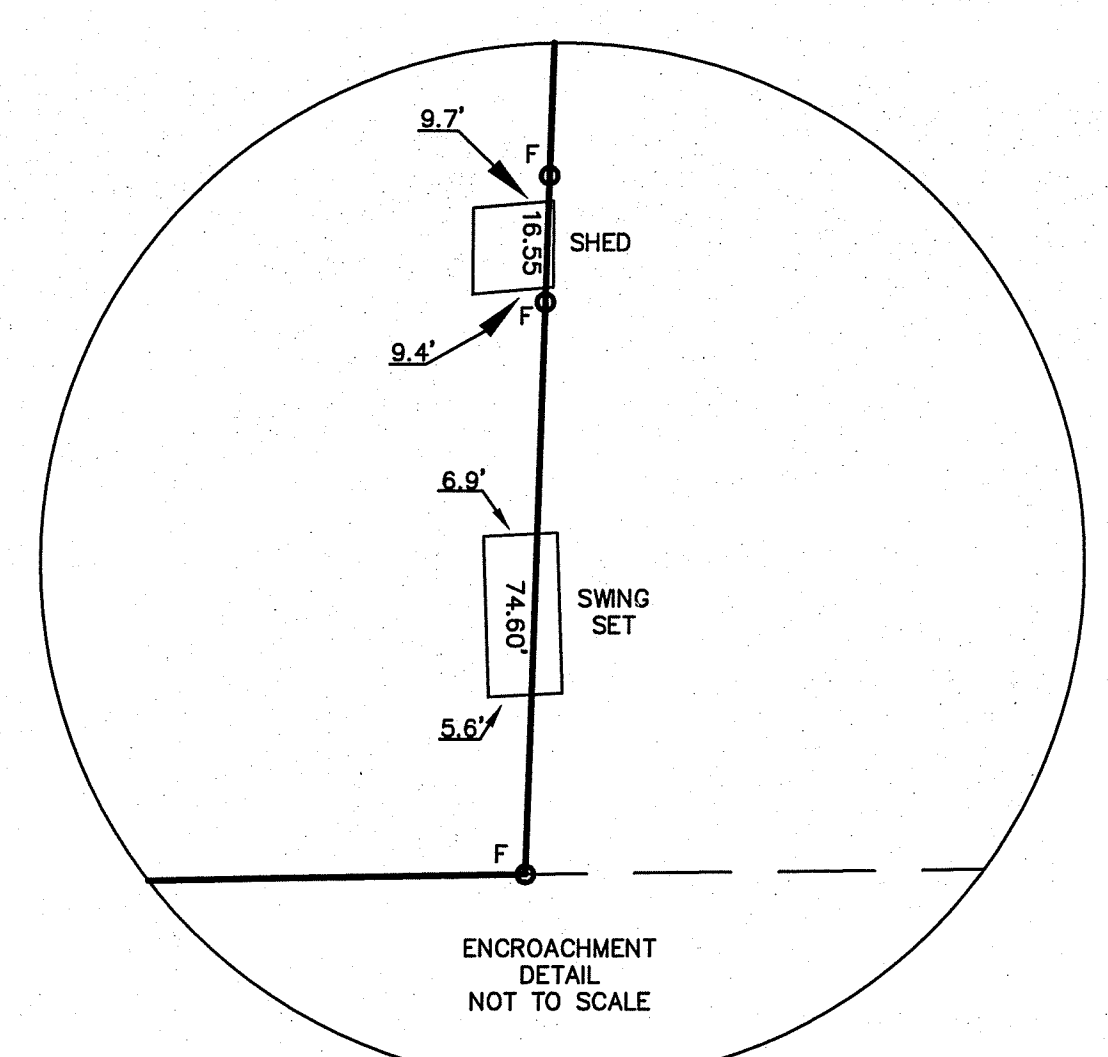

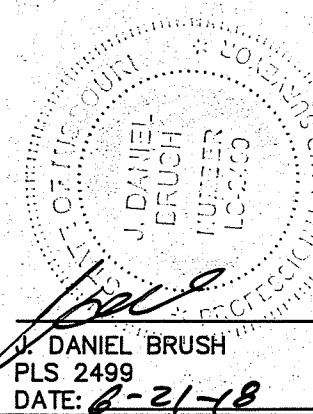
