Re: Issuance of a Liquor License to a Business Located Within 100 Feet of Church

## Executive Summary

An application has been made to the State of Missouri for the issuance of a liquor license to a business located at 107 North Ninth Street called Bread Brothers, LLC d/b/a Endwell Taverna, which is within 100 feet of a church. Section 311.080 of the Missouri Revised Statutes requires written permission of the City Council prior to the issuance of a liquor license to this business. The proprietor of Endwell Taverna operates the Ozark Mountain Biscuit Truck and Ozark Biscuit Bar. It has been published that the liquor license will be for a New York-style pizza and Italian food restaurant.

## Discussion

Section 311.080 of the Missouri Revised Statutes establishes that no license shall be granted for the sale of intoxicating liquor within 100 feet of any school, church or other building regularly used as a place of worship, unless the license applicant shall first obtain the written consent of the City Council.

City ordinances and codes do not require any buffer between schools/churches and establishments that sell alcoholic beverages. However, issuance of the Missouri liquor license requires the consent of the local government. Since 2017, Silverball, Parks Amusement Cantina, Sagua La Grande Cuban Café, Brookside Poolside, and Fuzzy's Taco Shop received City Council consent.

Consent also shall not be granted until written notice has been provided to all property owners within 100 feet of the proposed licensed premises, at least 10 days prior to consideration of this resolution. Such notification has been provided and staff has not received any feedback yet.
