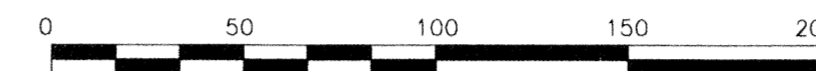

SAID TRACT IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

STARTING AT THE EAST 1/4 CORNER OF SECTION 4-48-12; THENCE S 89°-01'-00" W ALONG THE 1/4 SECTION LINE, 2062.5 FEET TO THE NORTHWEST CORNER OF BOONE COUNTY SURVEY #1743; THENCE S 0°-10'-00" E, ALONG THE WEST LINE OF SAID SURVEY, 1471.00 FEET; THENCE N 89°-01'-00" E 300.00 FEET TO THE POINT OF BEGINNING.

FROM THE POINT OF BEGINNING, CONTINUE N 89°-01'-00" E 220.40 FEET; THENCE S 0°-10'-00" E 266.30 FEET; THENCE S 89°-01'-00" W 12.90 FEET; THENCE S 3°-13'-00" W 60.00 FEET; THENCE N 89°-01'-00" E 250.00 FEET; THENCE S 3°-13'-00" W 184.25 FEET; THENCE S 88°-53'-00" W 388.02 FEET; THENCE N 26°-07'-00" E 227.50 FEET; THENCE N 1°-07'-00" W 193.80 FEET; THENCE N 88°-53'-00" E 32.50 FEET; THENCE N 27°-35'-08" E 35.00 FEET; THENCE N 0°-59'-00" W 80.20 FEET TO THE POINT OF BEGINNING AND CONTAINING 3.71 ACRES.

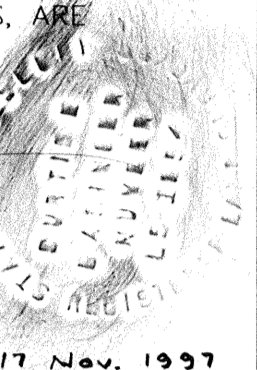
I THEN DIVIDED SAID TRACT INTO 12 LOTS AS SHOWN ON THIS PLAT.
