

**AMENDMENT NO. 2  
TO THE 2020 SOFTWARE AS A SERVICE AGREEMENT  
BETWEEN  
THE CITY OF COLUMBIA, MISSOURI,  
AND  
N. HARRIS COMPUTER CORPORATION**

This Amendment No. 2 to the March 3, 2020 Agreement between the **CITY OF COLUMBIA** ("Customer"), and **N. Harris Computer Corporation** ("Harris"), is made as of the date of the last signatory noted below.

**RECITALS**

- A. WHEREAS, on March 3, 2020, the Parties entered into an Agreement ("2020 Agreement") for the implementation services and annual software as a service subscription to Infinity.Link; and
- B. WHEREAS, Customer desired to later add a test environment and, on April 6, 2021, the Parties amended the 2020 Agreement to add Exhibit 1 to Schedule A of the 2020 Agreement ("Amendment No. 1");
- C. WHEREAS, the Parties later realized that Exhibit 1 to Schedule A incorrectly included a module called Energy Star Portfolio Manager;
- D. WHEREAS, the Parties desire to amend Exhibit 1 to Amendment No. 1 to remove all references to the Energy Star Portfolio Manager and to delete the fees associated with the Energy Star Portfolio Manager module; and
- E. WHEREAS, the Parties hereto desire to formally amend the 2020 Agreement with this Amendment No. 2 (hereinafter "Amendment No. 2") and desire to be bound by the terms contained in the 2020 Agreement as amended or supplemented by those terms contained in the Amendment No. 1 as modified by this Amendment No. 2.

**AMENDMENT**

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, the Parties agree as follows.

- 1. All references to Energy Star Portfolio Manager contained in Exhibit 1 of Amendment No. 1 shall be removed from the Agreement.
- 2. All fees associated with Energy Star Portfolio Manager shall be removed from the Agreement. The one time setup fee for Energy Star Portfolio Manager module, in the amount of \$5,000.00, has not yet been billed and will not be billed. Similarly, the annual recurring fee of \$15,220.00 will not be due or payable.
- 3. All other terms of the 2020 Agreement, as previously amended, shall remain unchanged and in full force and effect.

  - a. One Time Setup Fee - \$5,000 USD
  - b. Annual Recurring (additional) – \$15,220 USD

## Payment Terms (Credits)

One Time Setup Fee for Energy Start Portfolio Manager module has not been billed yet and thus, no changes required from Billing. The One Time Setup Fee of \$5,000.00 USD will not be billed as this module is being removed from the project scope.
