Re: Fetal and Infant Mortality Review (FIMR) Contract Amendment 01

## Executive Summary

An ordinance authorizing the City Manager to sign an amendment to the agreement between the State of Missouri, Department of Health and Senior Services (DHHS), and the City of Columbia, MO.

## Discussion

The City of Columbia received \$173,272.000 from the State of Missouri DHHS to address fetal and infant death. The funding would cover 1.0 FTE Planning Supervisor and other program related costs. The purpose of FIMR is to conduct in-depth, multidisciplinary reviews of fetal and infant deaths to better understand contributing local factors. By analyzing these findings, FIMR helps identify differences in care and outcomes, determine root causes, and guide actionable steps to prevent future losses and improve services for families. Columbia Boone Public Health and Services is the project lead for eighteen (18) central Missouri counties as the vast majority of fetal and infant death occur in Boone County. This amendment requires PHHS to identify an Institutional Investigator to review board qualifications and to assure compliance with the 1) FWA; 2) applicable Terms of the Federalwide Assurance for International Institutions (FWA) for DHSS, 3) the Belmont Report and; 4) 45 CFR part 46, which all outline requirements for human subjects, as stipulated in the IRB.
