Executive Summary

Authorize the Acceptance and Execution of a Road Relinquishment Agreement and Accept the Quit Claim Deed Relating to the transfer of a portion of Old Plank Road from the County Commission of Boone County for the Old Plank and Route K Roundabout project.

Discussion

The City of Columbia currently maintains (through a multi-jurisdictional Maintenance Agreement) Old Plank Road. The County of Boone will formally relinquish a portion of the southern part of the Old Plank Road right of way so that the City of Columbia may create a limited access roadway section along south Old Plank Road to meet Missouri Highway Transportation Commission requirements once the Old Plank Road and Route K Roundabout project has been completed. The Quit Claim Deed memorializes that relinquishment and shall be recorded by the City Clerk in the Recorder of Deeds office in Boone County.

The City of Columbia will continue maintenance of the roadway and establish limited access right of way along the southern most portion of Old Plank Road from Route K to the terminus of Old Plank Road.
