BEGINNING AT THE NORTHEAST CORNER OF SAID LOT; THENCE SOUTH 08 DEGREES 48 MINUTES 23 SECONDS WEST (BASED ON THE "MISSOURI COORDINATE SYSTEM OF 1983", CENTRAL ZONE 2401, GRID NORTH AS DERIVED FROM THE MODOT VRS SYSTEM), ON THE EAST LINE OF SAID LOT, 24.70 FEET; THENCE NORTH 48 DEGREES 32 MINUTES 38 SECONDS WEST, 68.92 FEET; THENCE SOUTH 69 DEGREES 03 MINUTES 06 SECONDS EAST, ON THE NORTH LINE OF SAID LOT, 59.36 FEET TO THE POINT OF BEGINNING.

SAID PERMANENT DRAINAGE EASEMENT CONTAINS 717 SQUARE FEET OR 0.016 ACRES, MORE OR LESS. AS SHOWN ON EXHIBIT "B" ATTACHED HERETO AND MADE A PART HEREOF. SUBJECT TO EASEMENTS, CONDITIONS AND RESTRICTIONS OF RECORD.

FROM SAID POINT OF BEGINNING; THENCE, CONTINUING ON SAID EAST LINE, SOUTH 08 DEGREES 48 MINUTES 23 SECONDS WEST, 26.44 FEET; THENCE NORTH 51 DEGREES 56 MINUTES 24 SECONDS WEST, 105.95 FEET; THENCE NORTH 01 DEGREES 13 MINUTES 46 SECONDS EAST, 20.00 FEET TO THE NORTH LINE OF SAID LOT; THENCE SOUTH 69 DEGREES 03 MINUTES 06 SECONDS EAST, 37.89 FEET; THENCE SOUTH 48 DEGREES 32 MINUTES 38 SECONDS EAST, 68.92 FEET TO THE POINT OF BEGINNING.

SAID TEMPORARY CONSTRUCTION EASEMENT CONTAINS 2,562 SQUARE FEET OR 0.059 ACRES, MORE OR LESS. AS SHOWN ON EXHIBIT "B" ATTACHED HERETO AND MADE A PART HEREOF. SUBJECT TO EASEMENTS, CONDITIONS AND RESTRICTIONS OF RECORD.


