

**First Amendment to
MEMORANDUM OF AGREEMENT**

Between Columbia Police Lieutenants' Association and City of Columbia

Effective: Upon execution by last signatory through September 30, 2026

The parties have met to further negotiate those issues reserved pursuant to the Memorandum of Agreement in effect for the period from October 1, 2023 to September 30, 2026 ("Agreement") and such other issues as have been negotiated on the mutual consent of the parties. The parties agree that these amendments to that Agreement have been made as a result of their good faith efforts to satisfy their obligations under Missouri law, and that the parties have met, discussed, and agreed upon a resolution of all issues raised by the parties.

These amendments replace sections of the Agreement as indicated herein. Unless expressly replaced herein, all provisions of the existing Agreement continue to apply up to the time of expiration on September 30, 2026. Terms defined in the Agreement shall have the same definition in this amendment.

Article 16 is replaced in its entirety with the following:

ARTICLE 16
SALARY

Effective September 15, 2024, minimum starting pay for Police Lieutenant shall be \$49.67 per hour.

Effective September 15, 2024, Current Police Lieutenants shall be assigned the following hourly rates:

- \$50.66: Lieutenants Gremore, Kaneaster, Muscato, and Sedgwick
- \$51.65: Lieutenants Alpers, Horrell, Sinclair
- \$52.64: Lieutenant Gooch

Annually beginning in 2025, accordance with Section 19-25 of the Code of Ordinances, the City and CPLA shall engage in good faith negotiations of the issue of salaried compensation. Any agreements reached must be approved in the same manner as this agreement and, upon approval by the Bargaining Unit Employees and the City Council shall be an amendment to the terms of this agreement.




