Re: Authorizing an Airport Aid Agreement for the Aircraft Rescue and Firefighting training at Columbia Regional Airport.

Executive Summary

Authorizing the City Manager to execute an Airport Aid Agreement with the Missouri Highways and Transportation Commission (MHTC). This agreement allows the reimbursement for past and future costs of Aircraft Rescue and Firefighting (ARFF) training at Columbia Regional Airport in fiscal year 2019 and fiscal year 2020.

Discussion

MHTC awarded funds to cover the costs of ARFF training provided by the University of Missouri Fire and Rescue Training Institute at the Columbia Regional Airport. This agreement reimburses the Columbia Regional Airport for the cost of training held in fiscal year 2019 and fiscal year 2020. The costs being reimbursed are \$4,000.00 each year for a total of an \$8,000.00 grant. MHTC desires to promote aviation safety by facilitating the effective training of fire, rescue and emergency service entities at Missouri Part 139 Airports in aircraft rescue firefighting techniques and other aspects of emergency response to fires, accidents and other emergencies involving aircraft.
