Re: Amending Chapter 22-29 of the City Code to Suspend Transportation Fares for Fiscal

Year 2026 for Users of the GoCOMO Public Transit System.

Executive Summary

Staff has prepared for Council consideration an ordinance amending Chapter 22-29 of the City Code to suspend transportation fares for Fiscal Year (FY) 2026 for users of the GoCOMO Public Transit System.

Discussion

Since the March 2020 Emergency Declaration, due to the COVID-19 pandemic, GoCOMO has been operating fare free. During the FY 2021 budget preparation meetings, the City Manager was made aware of GoCOMO's ability to manage expenses with current transportation sales tax (TST) funding and the Federal Transit Administration (FTA) operating grant and he recommended a pilot project to continue fare free for FY 2021. At the September 21, 2020 City Council meeting, Council approved the ordinance, amending Chapter 22-29 by suspending transportation fares for FY21 for users of the GoCOMO Public Transit System.

At the September 20, 2021 City Council meeting, Council approved GoCOMO to remain fare free for FY22 with the American Rescue Plan and Care Acts funding. Those funds have been expended.

The last full fiscal year to charge fares was FY2019. The Fixed Route revenue was \$247,322. Fares for the Fixed Route were \$1.50 for full fare, \$0.75 for half fare, and students under 18 rode for free. The Paratransit revenue was \$156,493. The fares for Paratransit were \$3.00 per ride. Ridership for Fixed Route during FY2024 was 348,150. Ridership for Paratransit in FY2024 was 61,502. Total FY2019 revenue for both services was \$403,915.

GoCOMO has the ability to manage expenses for FY 2026 with current transportation sales tax (TST) funding and the Federal Transit Administration (FTA) operating grant and is therefore requesting to amend Chapter 22-29 to suspend transportation fares for users of the GoCOMO Public Transit System for FY 2026.
