Executive Summary

An ordinance has been prepared to amend Chapter 16 of the City Code related to offenses within the City by repealing and replacing Division 23 of Article II, which regulates marijuana use and consumption. This ordinance will ensure the City Code offenses and enforcement thereof are in compliance with the Constitutional amendments enacted by Missouri voters.

Discussion

On November 8, 2022, the voters of Missouri approved Amendment 3 to the Missouri Constitution that contained revisions to Section 1 of Article XIV relating to medical marijuana and added a new Section 2 legalizing recreational adult use of marijuana. Section 2 of the Constitutional amendment legalizes the possession and consumption of marijuana for people 21 years of age and older and establishes a framework for the possession, consumption and cultivation adult-use marijuana.

Chapter 16 of the Columbia City Code regulates the personal use and medical use of marijuana for adults. By voter initiative, the City of Columbia had previously declared the use of medical marijuana recommended by a physician for seriously ill adults to not be subject to prosecution and limited the scope of prosecution for possession of less than 35 grams of marijuana. However, Amendment 3 to the Constitution goes further by legalizing the adult possession and use of up to 3 oz. of marijuana along with the cultivation of a limited number of marijuana plants and other marijuana activities that were previously unlawful within the State of Missouri.

The amendments proposed will modify the City Code provisions to ensure the provisions of the City Code do not conflict with Amendment 3 to the Constitution. Because the Constitutional amendment is more comprehensive than the 2004 Columbia Initiative, the existing provision of the City Code related to marijuana will be deleted and replaced with sections that conform to the new Constitutional amendment.
