Council Bill No. B 160-25

**AN ORDINANCE**

determining it is in the public interest to construct the Columbia Gorge Parkway sidewalk improvement project; approving and adopting plans and specifications; determining that the work shall be done by contract; calling for bids through the Purchasing Division; providing for payment for the improvement; amending the FY 2025 Annual Budget by appropriating funds; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law and state-mandated construction safety training; and fixing the time when this ordinance shall become effective.

WHEREAS, an interested parties meeting for the proposed construction of the Columbia Gorge Parkway sidewalk improvement project was held by the Public Works Department on May 27, 2025; and

WHEREAS, the City Council adopted a resolution declaring the necessity for the proposed construction of the improvement project; and

WHEREAS, the notice of a public hearing on this project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the proposed improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of the Columbia Gorge Parkway sidewalk improvement project in the City of Columbia, Missouri, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made. Specific improvements include the following:

- Construction of a five (5) foot wide sidewalk along the south side of Columbia Gorge Parkway and the west side of Pride Mountain Drive between the existing sidewalk adjacent to 5108 Columbia Gorge Parkway and 2203 Pride Mountain Drive.

- Construction of a pedestrian crosswalk across Pride Mountain Drive at Columbia Gorge Parkway.
- Construction of a pedestrian curb ramp to accommodate a future crosswalk across Columbia Gorge Parkway at Pride Mountain Drive.
- Construction of a pedestrian curb ramp at August Briggs Drive to connect to the existing sidewalk on the north side of Columbia Gorge Parkway.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of Public Works, are hereby approved.

SECTION 3. The construction of the improvement shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The Purchasing Agent is hereby authorized to call for bids and execute a contract for the improvement.

SECTION 5. Payment for this improvement shall be made from quarter-cent Capital Improvement Program (CIP) sales tax funds and such other funds as may be lawfully appropriated.

SECTION 6. The FY 2025 Annual Budget adopted by Ordinance No. 025767 is amended by appropriating funds as set forth in "Exhibit A" attached hereto and made a part hereof.

SECTION 7. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 8. Pursuant to Section 290.250 RSMo., the contract for the improvement project shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under any contract in excess of \$75,000.00. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 9. Pursuant to Section 292.675 RSMo., the bid specifications and contract for the improvement shall provide that the contractor and any subcontractor shall provide a ten-hour Occupational Safety and Health Administration construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations) for all employees working on-site. All employees working on the site of the improvement are required to complete the safety program within 60 days of beginning work on the improvement project.

SECTION 10. This ordinance shall be in full force and effect from and after its passage.
