Susan Renee Carter spoke on behalf of Race Matter Friends. She wants the Board to be concerned about how the public is represented. She asked the Board to stay focused on the citizens and asked the City to advocate for changes to the state law.

Chriss Jones spoke on behalf of Hold CoMo Accountable. Jones encouraged the Board to not narrow the definition of abuse of authority. Jones criticized Hunt over his interactions with police and their

representatives.

Coleman offered her support for Hunt and his many hours working on Board and working with community members. Castilow agreed with Coleman's support and expressed support for Hunt. Castilow said he feels better for the future of the Board and pointed to the openness of the definitions. Ellis said he will not be at the next meeting and will not seek reappointment with the Board. Ellis said he will speak at the next city council meeting in support of the Board. The board was disappointed in Ellis decision to leave the Board and thanked him for his service.
