#### HOUSING -



- Served over 2,000 households or 4500 individuals with housing and support services.
- 100 residents were able to move up into market-rate housing.
- Expanded our collaborative relationships with local landlords to over 364 property managers.
- Trained over 50 landlords and nonprofit partners on the resources CHA makes available for housing and ancillary programs.
- Expanded staff with a new Homeless
   Outreach Coordinator increasing
   homeless households to 51 who are
   now connected to permanent housing
   with support services.
- Awarded and utilized 88 additional special vouchers for homeless or atrisk households.
- Provided second chances to 27 applicant households who were denied housing based on criminal background checks by connecting them to supportive services.
- Considered an excellent indicator by HUD, CHA increased its voucherfunding utilization by \$1 million.

## **NEW HOUSING** -



- Awarded \$3 million from the Missouri Department of Economic Development to expand the Kinney Point Apartments by 10 units, as well as adding a community center.
- Secured \$34 million to redevelop and expand housing, which will rebuild 70 housing units and add 43 units of new housing, create over 100 jobs and increase local tax revenue by \$2 million, as well as underscore CHA's long-term sustainability.
- All of the CHA redevelopment conversion of properties to lowincome housing from affordable housing generate real estate tax credits for the county, city, schools, etc. – CHA housing is tax-generating.

## YOUTH —— PROGRAMS



The CHA Moving Ahead program is a quality, state-licensed, after-school, and summer program that offers an effective mix of one-on-one tutoring, and cultural and physical activities for students in Kindergarten through 12th grade.

- Invested over \$250,000 in our Moving Ahead Afterschool and Summer School Programming to serve an additional 40 youth.
- Completed \$50,000 in renovations to the Moving Ahead program located in the Boone Community Center to expand services.
- Funded an additional \$30,000 in programming and activities for CHA youth in partnership with local minority-led organizations.
- In collaboration with Job Point's workforce training program for lowincome, at-risk youth, broke ground on the construction of a new home.

## ADDITIONAL \_\_\_\_\_\_SUPPORT SERVICES



- Distributed over 100,000 pounds of nutritious food to CHA residents, in partnership with The Food Bank for Central and Northeast Missouri.
- Graduated 13 of 135 Family Self-Sufficiency households earning \$62,000 in matched savings from increases in employment and household income.

## STEWARDSHIP.

- Completed a new congressional initiative to enable comprehensive monitoring of public housing authorities.
- By request from the US Department of Housing and Urban Development, CHA assisted with peer-to-peer training on understanding redevelopment efforts.
