**AN ORDINANCE**

amending the FY 2022 Annual Budget by appropriating funds received from donations and miscellaneous revenues to provide funding for various Parks and Recreation Department projects; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2022 Annual Budget adopted by Ordinance No. 024752 is amended by appropriating the sum of \$40,000.00 from the MKT Wetland/Forum CIP Revenue Account Number 44008850-480000-00779 to the MKT Wetland/Forum Miscellaneous Contractual Account No. 44008850-604990-00779 for the construction of a boardwalk and installation of a plaque as part of the MKT Wetlands project located southeast of the Scott Boulevard Trailhead and the MKT Trail.

SECTION 2. The FY 2022 Annual Budget is further amended by appropriating the sum of \$65,000.00 from the Hinkson Creek Trail Stephens to Clark CIP Revenue Account Number 44008850-480000-00728 to the Hinkson Creek Trail Stephens to Clark CIP Miscellaneous Contractual Account No. 44008850-604990- 00728 for construction of the Walnut Street Bridge as part of the Hinkson Creek Trail: Stephens Lake Park to Clark Lane trail project.

SECTION 3. The FY 2022 Annual Budget is further amended by appropriating the sum of \$6,000.00 from the Bike Co-op Donations Account Number 23108554-480564 in the following amounts to the following accounts for staffing and supplies associated with the Bike Co-op program:
