1.) What concerns do you have related to vehicular traffic on West Ash?

The intersection of West Blvd and Ash has often been a safety issue. Cars often run the stop sign whether distracted or not knowing the intersection is there as it can be hard to see. West bound it can be hard to see, particularly when the sun is low. Also the absence of a eastbound bike lane between Glenwood and McBaine is dangerous. Cars often have to decide whether they will choose to share the lane. Cars often travel faster there as there are fewer homes in that section.

2.) What concerns do you have related to pedestrian traffic on West Ash?

There is no continuous sidewalk between Garth + Clarksdale. Often you may need to cross Ash multiple times to get to a destination. ~~there~~

3.) From a resident's perspective, improvements are needed along West Ash? <sup>what</sup>

A complete bikelane or pathway both directions without interruptions. There should be a highly visible crossing at Aldrich/Alexander and Ash. Traffic calming to slow and discourage through traffic that would be more suited for higher capacity sheet.

4.) Are there any improvements that you do not want and why?
