Executive Summary

Staff has prepared for Council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the construction of the Sanitary Sewer Rehabilitation Project #9. The public hearing for this project was held on December 20, 2021. The resolution estimate for this project is \$3,025,000 and will be paid from the Sanitary Sewer Utility Revenue Bonds approved in the 2013 ballot.

Discussion

The Sanitary Sewer Rehabilitation Project #9 will include rehabilitating sewer pipe and lateral connections to the main located primarily in two areas in Columbia. See the attached location map. Approximately 75,000 linear feet will be rehabilitated to repair structural deficiencies and to reduce Inflow and Infiltration (I&I) into the sewer main. The proposed rehabilitation project is a continuation of annual efforts to repair existing sewer infrastructure and reduce I&I as part of the Wastewater and Stormwater Integrated Management Plan. Reduction of I&I is part of the ongoing effort to reduce the number of backups into buildings and sanitary sewer overflows. Rehabilitation of sewer mains could occur throughout Columbia. As shown attached individual project graphics, two primary areas where several mains are proposed to be rehabilitated with this project include:

- Business Loop 70
- Downtown Area

Staff anticipates utilizing an existing term and supply contract for this project. This ordinance authorizes constructing the improvements through the City's term and supply contracts or bidding through Purchasing, as necessary. An Interested Parties (IP) meeting was held on November 9, 2021 for the primary affected areas. Six (6) people attended the meeting (not including staff). Staff communicated with others who were interested in the project but could not attend the meeting. A public hearing was held for this project on December 20, 2021. The resolution estimate for this project is \$3,025,000 and will be paid from Sanitary Sewer Utility Revenue Bond funds approved in the 2013 ballot. The project is anticipated to begin in 2022.

Fiscal Impact

Short-Term Impact: The resolution estimate for this project is \$3,025,000.

Long-Term Impact: Reduced maintenance and repair costs.
