Re: Authorizing construction of storm water improvements on Bray Avenue, east of Longwell Drive; calling for bids through the Purchasing Division or authorizing a contract for the work

using a term and supply contractor.

Executive Summary

Staff has prepared for council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the Bray Avenue at Longwell Drive Stormwater Improvement Project, as shown on the Location Map. The public hearing for this project was held on January 4, 2021. The resolution estimate for this project is \$200,000 and will be paid from Storm Water Utility funds.

Discussion

The Bray Avenue at Longwell Drive Stormwater Improvement Project will consist of constructing approximately 270 linear feet of new stormwater pipe, four (4) stormwater inlets, and one (1) stormwater structure as shown on the attached Project Graphic. The existing stormwater pipe system and two existing inlets will be removed or abandoned in place by filling with grout. Staff anticipates utilizing term and supply bidding process for this project. However, this ordinance authorizes construction either through the City's term and supply contracts or by bidding through Purchasing, whichever is most appropriate.

Stormwater Utility staff held an Interested Parties (IP) meeting on October 14, 2020. A public hearing for Bray Avenue at Longwell Drive Stormwater Improvement Project was held on January 4, 2021. The resolution estimate for this project is \$200,000 to be paid from Storm Water Utility funds. Construction plans are 90% complete, and all necessary easements have been obtained. Construction is expected in 2022.
