Executive Summary

This legislation authorizes 17 contracts with local arts and culture organizations for a total of \$150,000. Grant funds from the National Endowment for the Arts (NEA) – American Rescue Plan Grant to Local Arts Agencies for Subgranting in the amount of \$150,000 have already been appropriated.

Discussion

The Office of Cultural Affairs (OCA) was awarded a grant from the NEA to provide funds to be subgranted to local 501(c)(3) nonprofit arts organizations. The grant's purpose is to support subgranting to the nonprofit arts sector in response to and recovery from the COVID-19 pandemic. Part of the American Rescue Plan (ARP), these funds from the NEA are separate from and in addition to the \$25 million that the City received earlier this year.

The OCA administered a subgranting program with an application process similar to its annual arts funding process. The ARP funds can go toward arts organizations' personnel, stipends for artists, facilities, health and safety supplies, and marketing and promotional costs. There is no cost share required on the part of the City or the nonprofit organizations to receive funds.

The awards resulted from the Commission on Cultural Affairs review process of applications received from local arts organizations. Commissioners reviewed the proposals during two meetings and offered time for public comment at the June meeting. The following is a list of the organizations and award amounts:
