## **A RESOLUTION**

setting a public hearing; declaring the necessity for the proposed construction of improvements on Ash Street between Providence Road and Clinkscales Road; stating the nature of and the estimate of the cost of the proposed improvement; providing source of funds for payment for the proposed improvement; and providing for compliance with the prevailing wage law.

WHEREAS, interested parties meetings for the proposed construction of improvements on Ash Street between Providence Road and Clinkscales Road were held by the Public Works Department on March 8, 2022 and July 26, 2022, and walkthroughs of the project corridor were held on April 14, 2022 and April 30, 2022.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. A public hearing in respect to the proposed public improvements set forth herein will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on October 17, 2022. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.

SECTION 2. The City Council deems the proposed construction of improvements on Ash Street between Providence Road and Clinkscales Road, necessary to the welfare and improvement of the City but desires to hear from the public prior to taking further action to authorize construction of the project. Possible options and the estimated construction costs for the improvements are as follows:

Option 1: Under this option, improvements include the construction of an eight (8) foot wide sidewalk along the north side of Ash Street between Providence Road and Clinkscales Road, construction of a five (5) foot wide sidewalk and bicycle lane on the south side of Ash Street between Providence Road and Clinkscales Road, and pedestrian crosswalks with rapid blinking beacons at the Ash Street intersection with Redwood Road, Anderson Avenue, and Aldeah Avenue/Alexander Avenue. The estimated construction cost of these improvements is \$2,758,000.00.

Option 2: Under this option, improvements include the construction of a one hundred (100) foot diameter single-lane roundabout at the intersections of Ash Street and Clinkscales Road, Ash Street and West Boulevard, and Ash Street and Garth Avenue. The estimated construction cost of these improvements is \$550,000.00 per intersection for a total estimated construction cost of \$1,650,000.00.

Option 3: Under this option, improvements would be made to the four-way stops at the intersections of Ash Street and Clinkscales Road, Ash Street and West Boulevard, and Ash Street and Garth Avenue. The estimated construction cost of these improvements is \$365,000.00 per intersection for a total estimated construction cost of \$1,095,000.00.

SECTION 3. The nature and scope of the proposed improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements. Following the public hearing the City Council shall determine whether it is in the public interest to make the proposed public improvements or any part thereof.

SECTION 4. Payment for this proposed improvement shall be made from quartercent Capital Improvement Program (CIP) sales tax funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the proposed improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.
