Executive Summary

Council has authorized a public hearing to consider approval of the FY 2022 CDBG and HOME Annual Action Plan.

Council action on the accompanying resolution will authorize the City Manager to resubmit the FY 2022 CDBG and HOME Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD).

The Plan reports how the funding Community Development Block Grant and HOME Investment Partnerships grant allocations will be used to achieve the goals outlined in the City's Consolidated Plan. Allocations within the FY 2022 Annual Action Plan were adjusted from estimated amounts originally included within the FY 2022 City budget to align with final allocations approved through the congressional budgeting process. A public hearing is required by HUD in accordance with the City's Citizen Participation Plan.

Council conducted a public hearing on the Annual Action Plan on August 15, 2022; at that time staff anticipated that the Plan would need to be resubmitted to HUD to satisfy the required 30-day comment period. The HUD field office has indeed required the plan to be re-heard and re-submitted. Staff has published a new notice that allows for a 30-day comment period through October 3, 2022.

Discussion

Approval of the FY 2022 Annual Action Plan is required in order to receive CDBG and HOME program funding for FY 2022 projects. The final allocation amounts are as follows: \$1,014,077 in CDBG and \$630,924 in HOME. Funds were allocated to projects and programs in 2021. The Housing and Community Development Commission recommended \$1,000,000 in CDBG be allocated to projects and programs and \$600,000 in HOME funds. The HOME funding recommendations were made in two stages: In August 2021 the HCDC recommended full funding of \$395,000 in HOME requests; in December 2021, the HCDC recommended that the balance of \$205,000 be allocated to an additional project in response to a second request for proposals. The draft Action Plan makes adjustments to the Home Rehabilitation Program, CDBG Administration/Planning, Homeownership Assistance Program, Community Housing Development Organizations set-aside, and HOME Administration to allocate the additional funds.
