Re: Authorizing the Temporary Closure of the Parking Lane and Redirection of Sidewalk on East Broadway, Temporary Closure of the Parking Lane and Sidewalk on South Tenth Street, and Temporary Closure of the Alley behind 1000 East Broadway.

Executive Summary

Staff has prepared for Council consideration a resolution authorizing Discovery Development, LLC, to temporarily close the parking lane along East Broadway, the parking lane and sidewalk along South Tenth Street, and the alley behind 1000 East Broadway from October 18, 2022, through August 15, 2023, to construct a new building at 1000 East Broadway.

Discussion

The closure from October 18, 2022, through August 15, 2023 includes:

- Portions of the parking lane along the south side of East Broadway between South Tenth Street and Hitt Street.
- Portions of the parking lane and sidewalk along the east side of South Tenth Street between East Broadway and Cherry Street.
- Portions of the alley behind 1000 East Broadway.

Discovery Development, LLC, will be constructing a new building at 1000 East Broadway. Staff has reviewed the attached traffic control plan and has no other issues with their request. Staff has previously approved a 30-day closure permit for the closure of the parking and sidewalk along East Broadway and South Tenth Street for the demolition of the previous building at 1000 E Broadway. Council has previously extended the initial closure through October 17, 2022, with the understanding that the developer would rework the closure plan to include a protected walkway to allow pedestrian traffic along East Broadway to remain open.

In order to facilitate the protected walkway a brick planter was removed. Staff recommends that the developer be obligated as part of this resolution to install an equivalent new planter prior to project completion. Staff is currently in discussions with the District regarding a long term vision for the downtown planters. Therefore, should the cost of the new planter exceed the cost of what was previously in place, the developer should only be responsible for the equivalent of what was removed.

Discovery Development, LLC, will also need to close one or both lanes of South Tenth Street for 3-5 days to connect to the existing sewer and water mains that are located in the middle and west side of South Tenth Street. Staff is currently working with the developer on a closure plan for the utility connections that will have the least impact on traffic and transit.
