## Executive Summary

Approval of this request would set December 5, 2022, as the date for a public hearing on the 2022 update to the Columbia Sidewalk Master Plan (SMP). The intent of the SMP is to prioritize potential sidewalk projects where sidewalks do not exist and aids in identifying and applying for grant-eligible projects as well as in making capital budgeting decisions by identifying the most critical sidewalk improvements and construction locations throughout the City. The Plan was previously updated in 2013 and contained 41 total projects.

### Discussion

The City has maintained a Sidewalk Master Plan (SMP) since 1976, with updates in 1981, 1996, 1997 and 2007. The intent of the SMP is to prioritize potential sidewalk projects where sidewalks do not exist. The Master Plan further aids the staff and City Council in identifying and applying for grant-eligible projects as well as in making capital budgeting decisions by identifying the most critical sidewalk improvements and construction locations throughout the City. The existing plan was approved by the City Council in April, 2013. It contained 41 projects.

Given the Sidewalk Master Plan is similar to other master plans (i.e. the Comprehensive Plan, Parks & Recreation Master Plan, Integrated Resources Master Plan, etc.) for infrastructure within the City for which public hearings are held and given prior practice, a public hearing before the final adoption of the updated plan is appropriate.

The preparation of the plan has engaged several boards and commissions throughout 2022. Of the boards and commissions engaged, the Bicycle and Pedestrian Commission took the lead in discussing the contents of the document as is outlined in their Duties and Responsibilities. Additionally, the Disabilities Commission, Public Transit Advisory Commission, and the Planning and Zoning Commission reviewed the updated plan offering comments at their June 9, May 17, and August 4 & 18 meetings, respectively. The Planning and Zoning Commission held a public hearing on the proposed plan at their October 20, 2022 meeting as has been past practice.

The updated plan includes a total of 40 projects (31 from the 2013 SMP and 9 new). The estimated cost to implement those projects is \$24,670,080. Ten projects from the 2013 SMP have been completed or are funded/in process. Another 2013 SMP project was rejected by the City Council and is no longer listed.
