Case Number 282-2022

A request by Buxton Kubik Dodd Design Collective (agent), on behalf of BB Lot 5, LLC (owner), for approval of a major amendment to the Houlihan's C-P Plan, located on Lot 5 of Broadway Bluffs Subdivision, to increase the permitted building gross floor area from 8,000 to 8,500 square feet, and enclose an existing covered patio for a new restaurant to be known as Walk-On's. The approximately 1.69-acre property is located on the north side of Broadway Bluffs Drive, approximately 750 feet east of Broadway, and includes the address 2541 Broadway Bluffs Drive.

MS. GEUEA JONES: May we please have a staff report.

Staff report given by Mr. Clint Smith of the Planning and Development Department. Staff recommends approval of a major amendment for the Broadway Bluffs Subdivision Lot 5 - Walk-On's PD Plan.
