**Justification of Transfer**

The original intent for this funding was to develop a mobile crisis team as a unit of the Dept. of Public Health and Human Services, However, due to the level of pay for the positions in the City's pay plan, we have been unable to hire the staff to build the program. We were also unable to secure a partnership with Boone County joint communications to facilitate dispatch for the mobile crisis team. In the meantime, we have learned the Missouri Dept. of Mental Health are implementing mobile crisis teams via their regional administrative agents, also known as Community Behavioral Health Centers. It is our understanding these mobile crisis teams will be deployed through the regional behavioral health crisis lines and 988.

These factors led us to pivot to reconsidering a co-responder program, to be embedded in the Columbia Police Department. We are actively pursuing the purchase of crisis intervention, crisis counseling, and case management services from the state contract for the administrative agent for our region. If that approach is not successful we will issue an open request for proposals for these services. In either case, the applicable expense account for the purchase of services is the contractual services account, hence the request to transfer all budgeted funds to the account indicated.
