

**CITY COUNCIL MEETING MINUTES

**INTRODUCTORY**

The City Council of the City of Columbia, Missouri met for a regular meeting at 7:00 p.m. on Monday, November 21, 2022, in the Council Chamber of the City of Columbia, Missouri. The Pledge of Allegiance was recited, and the roll was taken with the following results: Mayor BARBARA BUFFALOE, Council Member PAT FOWLER, Council Member ANDREA WANER, Council Member ROY LOVELADY, Council Member NICK FOSTER, Council Member MATT PITZER, and Council Member BETSY PETERS were present. City Manager De'Carlton Seewood, City Counselor Nancy Thompson, City Clerk Sheela Amin, and various Department Heads and staff members were also present.

Council Member Foster made a motion to not hold a regular city council meeting on January 3, 2023. The motion was seconded by Mayor Buffaloe.

The Council discussed the motion.

The motion made by Council Member Foster and seconded by Mayor Buffaloe to not hold a regular city council meeting on January 3, 2023 was approved by roll call vote with Mayor Buffaloe, Council Member Lovelady, Council Member Foster, Council Member Pitzer, and Council Member Peters voting yes, and Council Member Fowler and Council Member Waner voting no.

The Council and staff continued its discussion on various topics to include the bus route going to the VFW/RATI facility, B331-22 being placed under old business at the next meeting and for the Council to consider tabling it to the December 19, 2022 council meeting, and the proposed RFP involving the Unified Development Code (UDC).

Council Member Peters explained she was on the Hinkson Creek CAM Stakeholder group, and they needed to replace two members. The suggestions were Scott Hamilton, who resided within that watershed and worked for the U.S. Fish and Wildlife Service, for the property owner vacancy, and Richard Perkins for the CPS representative vacancy. Mayor Buffaloe asked if there was any objection to those recommendations, and no one voiced an objection.

The Council and staff continued its discussion on various topics to include the good work of the Parks and Recreation Department in stretching the City's tax dollars, the fact the Council was respectful compared to

stories heard at the NLC Conference regarding other communities, and the trip to Memphis to visit the Civil Rights Museum.

The meeting was adjourned without objection at 12:19 a.m.
