Re: Public Hearing for the Audubon Drive and Shepard Boulevard Traffic Calming Project

Executive Summary

Public Hearing to consider the installation of traffic calming devices on Audubon Drive between Stadium Boulevard and Shepard Boulevard, and on Shepard Boulevard between Old 63 South and Audubon Drive. The estimated cost of the project is \$70,000.

Discussion

Shepard Boulevard scored as the fifth highest priority project within the 2020 Neighborhood Traffic Management Program (NTMP), with a score of 79.56 out of a possible 100. Audubon Drive scored as the 11th highest priority project within the 2020 Neighborhood Traffic Management Program (NTMP), with a score of 69.33 out of a possible 100. The scoring system takes a number of factors into consideration including speed, volume, pedestrian generators in the area, proximity to schools, bike routes, and recent crash history. The majority of the scoring (2/3) is based on speed and volume of vehicles. The speed limit on Shepard Boulevard is 25 mph; however this street scored at the 85th percentile speed of 39.52 mph and has over 1,300 vehicles traveling on it per day. The speed limit on Audubon Drive is 25 mph; however, this street scored at the 85th percentile speed of 36.11 mph, and has over 1,300 vehicles traveling on it per day.

Two Interested Parties (IP) meetings were held for this project. The first IP meeting was held on December 13, 2021. The second IP meeting was held on June 8, 2022.

During the first IP meeting, staff gathered information from the public and listened to potential solutions. Support for traffic calming to encourage lower speeds was mixed from those providing comments.

Using information gathered at the first IP meeting and the Public Hearing for the proposed Audubon Drive sidewalk project, preliminary plans were developed and presented during the second IP meeting. Those providing comment and in attendance had mixed responses to the proposed traffic calming.

Based on comments received during the second IP meeting comment period, a proposed speed hump on Audubon Drive north of Shepard Boulevard was removed from the preliminary plan.

Following the second IP meeting, the Shepard Neighborhood Association held a vote of its members for support of the proposed traffic calming plan. The results of this vote indicated 37% of households are in favor of the proposed traffic calming plan, and 63% of households

are not in favor of the proposed plan. However, of the 49 households that are directly on either Audubon Drive or Shepard Boulevard and responded to the vote, 65% are in favor of the proposed traffic calming plan, and 35% oppose the proposed plan.

Staff would like to proceed with the construction of seven speed humps, two speed tables, and three crosswalk improvements on Shepard Boulevard and Audubon Drive during the 2023 construction season.

The calming devices will be located at the following locations:

- One speed hump for each direction on Shepard Boulevard near 2212 Shepard Boulevard
- Speed hump on Shepard Boulevard near 2317 Shepard Boulevard
- Speed hump on Shepard Boulevard near 2411 Shepard Boulevard
- Speed hump on Audubon Drive near 1401 North Azalea
- Speed hump on Audubon Drive near 1305 Audubon Drive
- Speed hump on Audubon Drive near 1101 Audubon Drive
- Speed table on Shepard Boulevard at Danforth Drive with all-way stop removal
- Speed table on Audubon Drive at South Azalea
- Crosswalk improvements on Shepard Boulevard at Danforth Drive
- Crosswalk with bulbout islands on Shepard Boulevard at Bucks Run
- Crosswalk with bulbout islands on Audubon Drive at Meadowlark Lane

Fiscal Impact

Short-Term Impact: The estimated cost for the installation of a series of seven speed humps, two speed tables, and three crosswalk improvements on Shepard Boulevard and Audubon Drive, including signs and markings, is \$70,000 paid from Annual Traffic Calming Funds. Long-Term Impact: Staff anticipates the replacement of the traffic calming devices every 15 years.
