Executive Summary

Setting a public hearing for May 1, 2023, to consider the installation of traffic calming devices on Russell Boulevard between Broadway and Rollins Road. The estimated cost of the project is \$20,000.

Discussion

Russell Boulevard scored as the 6th highest priority project within the 2021 Neighborhood Traffic Management Program (NTMP), with a score of 76.00 out of a possible 100. The scoring system takes a number of factors into consideration including speed, volume, pedestrian generators in the area, proximity to schools, bike routes, and recent crash history. The majority of the scoring (2/3) is based on speed and volume of vehicles. Russell Boulevard scored at the 85th percentile speed of 40 mph and has over 700 vehicles traveling on it per day.

Two Interested Parties (IP) meetings were held for this project. The first IP meeting was held on October 10, 2022. The second IP meeting was held on January 30, 2023.

During the first IP meeting, staff gathered information from the public and listened to potential solutions. The majority of those in attendance and providing comments were supportive of traffic calming efforts.

Following the first IP meeting, transportation advocacy organization Local Motion held a "pop-up" horizontal traffic calming event with the neighborhood. Temporary horizontal calming features, including bulb-out islands and a median island, were installed. Horizontal deflection hinders the ability of a motorist to drive in a straight line by creating a horizontal shift in the roadway. This shift forces a motorist to slow the vehicle in order to comfortably navigate the measure. Feedback from this event received by Local Motion is included in the IP1 Public Comments documentation. The feedback from this event indicates residents on Russell Boulevard do not support the implementation of horizontal calming.

Preliminary plans were developed and presented during the second IP meeting. Mixed support for traffic calming was received during this comment period.

Several comments were received requesting the implementation of signing to reduce operating speeds on Russell Boulevard. In response to these comments, two 25 mph "Kid Friendly" speed limit signs were installed on Russell Boulevard. These signs were left in place for three weeks and speed data was collected. The 85th percentile speeds along Russell

Boulevard have remained constant or increased compared to the speed data collected in 2019.

The implementation of Level 1 traffic calming (enhanced speed limit signing) has been ineffective at reducing operating speeds on Russell Boulevard. Staff would like to proceed with the construction of five speed humps on Russell Boulevard during the 2023 construction season.

The calming devices will be located at the following locations:

- Speed hump on Russell Boulevard near 101 Russell Boulevard
- Speed hump on Russell Boulevard near 209 Russell Boulevard
- Speed hump on Russell Boulevard near 403 Russell Boulevard
- Speed hump on Russell Boulevard near 503 Russell Boulevard
- Speed hump on Russell Boulevard near 509 Russell Boulevard

Fiscal Impact

Short-Term Impact: The estimated cost for the installation of a series of five speed humps, including signs and markings, is \$20,000 paid from Annual Traffic Calming Funds. Long-Term Impact: Staff anticipates the replacement of the traffic calming devices every 15 years.
