
Good Morning Andrew,

I live at 310 Russell and believe traffic calming devices would be a major nuisance to Russell Blvd. People who walk in the street on Russell should think about using the sidewalk or getting a treadmill. A major consideration should be the *International Fire Code (IFC)* Section 503.4.1 states that traffic calming measures placed on fire apparatus access roads "shall be prohibited unless approved by the fire code official." To better ensure coordination with the fire department during traffic calming implementation.

There is no direct route to Russell school for Emergency Services. On any other street besides Russell because all other streets have traffic tables in place. "An ambulance can be affected by a traffic calming measure, especially a vertical deflection measure. The effects include both the delay associated with slowing to traverse a measure and potential discomfort for those being transported."

"The needs of ambulances should be considered when developing a traffic calming plan. In some locations, the fire department can speak to the needs of ambulance services; other locations may require the traffic calming practitioner to reach out to individual ambulance providers." https://safety.fhwa.dot.gov/

-This is just a few things to consider while trying to come up with a solution.

Hello,

My husband and I would like to offer some feedback on the traffic calming. We live on Oakwood Court and agree that Russell has gotten out of hand and something needs to be done. We have both almost been hit by cars coming over the hill multiple times while crossing Russell to get the side walk when we walk our dog. Our thoughts:

- 1. The majority of the speed racers seem to be cutting through our neighborhood to bypass the intersection at Stadium and Broadway.
- 2. When this was an issue on College several years ago, speed humps were installed and bingo, problem solved. If people speed, they learn the hard way to slow down.
- 3. The traffic calming that was done in front of Russell Elementary made the intersection with Russell more dangerous. I have witnessed cars moving to the center of the road to bypass the curb jutting out, almost hitting people (kids too), people on bikes and other cars. This does not slow people down in our experience. This area is very dangerous because teachers park down Russell on both sides of the road making it too narrow for 2 lanes of traffic to pass. School busses go down Russell, and trucks and emergency vehicles. Making the already narrow street more narrow is a confusing prospect. Many people park on the street full time.
- 4. When the pop up demonstration was going on at Sappington and Russell, we walked our dog through that area multiple times a day. Cars would slow at first until they realized what it was, and then gun it and go faster, swerving toward the center of the road.

Questions:

- 1. When the speed humps worked so well on College, why can't we consider what we know works and does so without creating more dangerous conditions?
- 2. Is the plan to put the traffic calming curbs every 30 feet or so? In not, I don't understand the point. Speed humps are generally spread out to prevent people from speeding once they are through one.
- 3. Will measures be taken to allow parking on only one side of the street if this is done? Between cars and the curbs, the road will be too narrow. This also impacts snow plows. A neighbor plows Russell School area (Russell and Rollins) because the plows can't get to the curb because of the measures taken there.
- 4. Has the decision to do this been finalized, or is this even up for discussion?

We agree something needs to be done. Ideally, it would be something that works with the people who live here, not against us. Humps were recently added to Scott Blvd, so we know it's an option. If the goal is to improve safety, maybe it would be a good decision to consider the street lights that don't function. The one at Russell and Oakwood only turns on after a car or people go past it, and even then it is too dim. We were told it was due to light pollution, but I'd rather not get hit by a car.

This is difficult to write out, and I'm sure you can tell we have strong thoughts about this. Please feel to set up a time to talk of you are interested in more information or have questions.





Q1 Do you live directly on Russell Blvd?





Q2 Do you believe Russell Blvd. needs traffic calming? (Traffic calming means the design of the street slows down unsafe driving speeds.)





Q3 Did you notice the temporary pop-up traffic calming demonstration at the intersection of Russell Blvd. and Sappington Dr.?








Q6 What type of traffic calming solution would you like to see on Russell Blvd? (can select multiple) (Here are some traffic calming design examples.)





Hello,

I live at 210 Russell Blvd. and want to express my opinion on the traffic situation on Russell. Many cars and trucks travel much too fast for a neighborhood street. The traffic calming demonstration does not appear to be the solution. Cars can veer to the side of the poles without slowing down and could hit the side of the road or hit the pole and cause a problem with oncoming traffic. The placement of the "calming" also may cause problems with parking or turning into driveways. The one on Russell blocked my neighbors house where she often has visitors park. I found turning into my driveway when coming from the south was difficult. A larger vehicle or someone pulling a trailer would most likely cross over the curb which over time could create a rut.

My preference for solving the problem are speed bumps like those on College Park. They slow people down and are not that inconvenient. They also take up less street space than the "calming" obstruction. I think carefully placed speed bumps are a better solution for slowing down traffic.

I also think we need a 3 way stop at the intersection of Rollins and Russell. The structure put in there helps pedestrians but cars approaching each other on Rollins are close to hitting each other if they meet in the narrow part of the crosswalk. A car may speed up to get through before the oncoming car and fail to notice a child getting ready to cross the street.



Good morning!

I know that it certainly would have helped had I actually attended any of the meetings regarding the traffic calming proposals for Russell Blvd. But... So, my apologies for giving additional input without having previously participated.

I'm uncertain why I envisioned speed humps, similar to those just south on College Park, to be the traffic calming solutions to be implemented on Russell when I received the previous mailer/flyer and sent an email comment at that time. But, having now seen the proposed, what presume to be 6+ inch tall vertical, concrete curbs and not the humps, I do have additional concerns, mainly in that they could inflict great amount of damage to vehicles if accidentally struck, either by being placed too close to someone's driveway and being difficult to see when backing out, or simply by the casual driver who might make a small mistake when driving at a perfectly normal speed.

Speed humps, on the other hand, would not be an issue for residents backing out of driveways and running over them, and would not cause damage to a vehicle passing over them when driving at a casual speed, at, or typically below, the speed limit.

While I do not know how many obstacles are proposed down the length of Russell Blvd, or where the others might be located (I guess I need to look at your online maps next, but wanted to get this written before my day officially begins), I am concerned about the truly intrusive nature and potential damage to the vehicle of a casual driver that are highly likely to occur with what appear to be proposed.
