Re: Authorizing an Operations Agreement with The Boone County Fair, Inc. for the 2023

Boone County Fair.

Executive Summary

This resolution authorizes the operations agreement for the Boone County Fair, July 17, 2023 through July 22, 2023, at the Northeast Regional Park located at 5212 North Oakland Gravel Road, Boone County, Missouri.

Discussion

The Boone County Fair, Inc., has submitted a Special Event Permit application for the 2023 Boone County Fair. Set up for the fair will be on Saturday, July 15, 2023 and Sunday, July 16, 2023 from 7:00 a.m. until 10:00 p.m. The fair will operate on Monday, July 17, 2023 from 4:00 p.m. until 7:00 p.m. and on Tuesday, July 18, 2023 through Saturday, July 22, 2023 from 5:00 p.m. until 11:00 p.m. each evening. Clean up will be completed by Sunday, July 23, 2023 at 11:00 p.m.

The City Special Events Committee has worked closely with Boone County Fair Board members to address all aspects of the application to develop plans including but not limited to: festival layout, public safety plan, alcohol management plan, insurance, solid waste plan, accessibility plan, food service plans, and entertainment plans.

Because of the size and scope of this fair and because it requires city services and equipment, an agreement must be executed between the city manager and event organizer, and approved by the City Council, per Section 24-73(b) of the City Code.

The City Event Committee and the Organizer will continue to work together prior to the start of the fair to ensure all plans are approved by the appropriate City staff and departments to ensure a safe and successful event for all involved.
