Executive Summary

Staff has prepared for Council consideration a resolution authorizing the City Manager to execute a lease purchase agreement with Community Leasing Partners, Inc for ten (10) new Battle Motors Sidewinder Series Packer trucks and three (3) new Freightliner M2 Wolverine Series Packer trucks. Per Council direction, this agreement provides the vehicles necessary to implement automated refuse collection for residential curbside customers.

Discussion

As directed by Council, staff is working to implement automated refuse collections for residential curbside customers. This proposed lease purchase agreement will provide the Solid Waste Utility with ten (10) new Battle Motors Sidewinder Series Packer trucks and three (3) new Freightliner M2 Wolverine Series Packer trucks that will be used for residential curbside automated refuse collection. It is anticipated that curbside automated refuse collection will begin on March 4, 2024.

City Purchasing processed Request for Proposal 49/2023 for the lease of automated side loader refuse trucks. Staff has reviewed the proposals submitted and have chosen the proposal from Elliot Equipment with lease financing through Community Leasing Partners as the lowest and best option. Staff is proposing to procure the automated side loader refuse trucks through a 5-year lease purchase agreement with Community Leasing Partners.

As part of the lease purchase agreement, Elliot Equipment will provide routine service for all 13 vehicles to include all routine fluid & filter changes (engine oil, transmission and hydraulic) as well as fuel and coolant filter changes.

Staff is proposing to utilize funds in the Solid Waste Utility budget that were previously allocated for the purchase of refuse bags for this lease purchase agreement.

Fiscal Impact

Short-Term Impact: The total annual cost of the lease purchase agreement is \$830,946.54 Long-Term Impact: The total cost for the lease purchase agreement over the 5-year period is \$4,154,732.70. At the end of the 5-year period, the Solid Waste Utility can end the lease agreement and return the vehicles to Elliot Equipment or make a \$1,568,020.94 payment and retain the vehicles.
