Re: Missouri Department of Economic Development – Missouri ARPA Community Revitalization Grant Program – Orr Street Park Property Development

## Executive Summary

The Parks and Recreation Department is requesting an ordinance authorizing the City Manager to sign a grant agreement with the Missouri Department of Economic Development. The grant is provided to the City through the Missouri ARPA Community Revitalization Grant Program and will offset expenses associated with the FY2023 capital improvement project for the development of the Orr Street park property. The grant funding, totaling \$1,250,000, will be used for planning and constructing park amenities at the Orr Street Park property. The department is also requesting City Council approval to appropriate the grant funds to the Orr Street Park capital improvement project. The grant requires a minimum 50% match from the recipient, and matching funds are provided by the 2015 Park Sales Tax and 2021 Park Sales Tax. Staff will return to City Council for project approval after park staff completes the public input process for the proposed development of the park. The grant requires all construction related to the project be completed by Sept. 30, 2026.

## Discussion

In November 2022, park staff submitted a grant application for the development of the Orr Street park property to the Missouri Department of Economic Development for funding available through the Missouri ARPA Community Revitalization Grant Program. The competitive grant program was designed to make significant financial investments in communities of all sizes throughout Missouri. The funding opportunity was designed to support major local priorities in order to spur economic recovery and help communities build stronger economies for the future. The Program is funded through U.S. Department of the Treasury Coronavirus State and Local Fiscal Recovery Funds authorized by the American Rescue Plan Act (ARPA).

The Parks and Recreation Department is requesting an ordinance authorizing the City Manager to sign an agreement with the Missouri Department of Economic Development. The agreement outlines the acceptance of \$1,250,000 in grant funding to be used for the development of the Orr Street park property. The department is also requesting City Council approval to appropriate the grant funds to the Orr Street Park capital improvement project.

After the grant agreement has been finalized and the grant funding is appropriated to the project, park staff will begin the public input process for the development of the park. Park staff will host multiple in-person public input meetings in June and July and will utilize [beheard.como.gov](https://beheard.como.gov) to collect online feedback about the proposed improvements at the park property. After park staff has completed the public input process for the project, staff will hold a public hearing for the capital improvement project at the July or August Parks and

Recreation Commission meeting and will then return to City Council to request project approval to proceed with the development of the park property.

The funding provided through the Missouri ARPA Community Revitalization Grant Program requires a minimum 50% match by the receiving organization. The match for the grant in the amount of \$1,250,000 is funded by the 2015 Park Sales Tax and 2021 Park Sales Tax. The grant requires all construction related to the project be completed by September 30, 2026.

### Fiscal Impact

Short-Term Impact: Park staff is requesting City Council approval to execute an agreement with the Missouri Department of Economic Development to accept \$1,250,000 in grant funding provided by the Missouri ARPA Community Revitalization Grant Program and to appropriate the grant funds to the Orr Street Park capital improvement project. The grant program requires a minimum 50% match by the receiving organization. The match for the grant in the amount of \$1,250,000 is funded by the 2015 Park Sales Tax and 2021 Park Sales Tax. The 2022 acquisition of the Orr Street property from Ameren, totaling \$950,000, was allowed to be used as part of the matching funds provided by the City. These funds were part of the land acquisition funding in the 2015 Park Sales Tax. The remaining funds, totaling \$300,000, are from the 2021 Park Sales Tax.
