**AN ORDINANCE**

amending Ordinance No. 025333 to correct a scrivener’s error as it relates to Amending the FY 2023 Annual Budget by adding positions in the Department of Public Health and Human Services and the FY 2023 Annual Budget Appendix – Authorized Full Time Equivalent (FTE) position identification summary; and fixing the time when this ordinance shall become effective.

WHEREAS, Ordinance No. 025333 passed by the City Council on May 1, 2023 authorized a program services contract with the Missouri Department of Health and Human Services for HIV case management services; amended the FY 2023 Annual Budget by appropriating funds; amended the FY 2023 Annual Budget by adding and deleting positions in the Department of Public Health and Human Services; amended the FY 2023 Annual Budget Appendix - Authorized Full Time Equivalent (FTE) position identification summary; and amended the FY 2023 Classification and Pay plan by adding, closing, and reassigning classifications; and

WHEREAS, Sections 3 and 4 of the ordinance contained a typographical error in which 1.00 FTE HIV Medical Case Coordinator position was added rather than 7.0 FTE positions as requested; and

WHEREAS, the City Council wishes to correct this error by amending the ordinance.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Section 3 of Ordinance No. 025333 is corrected as follows:
