Hello Jacob,

We have received your request below and I think a conversation about our scope of work is necessary for us to provide an accurate proposal.

I see that both the Lynn Street Cottages and Cullimore Cottages were previously platted by subdivision plat with the common area defined around each "building" prior to their construction. We'll need to know if you are looking for a replat to make the area around the house different than it was previously, it appears some houses may not be fully within the lots as they were created. That would be very different than descriptions and displays of easement areas around the houses to know where they could/should be mowing.

If you could give me a call at your convenience we will be able to define which direction we would need to be heading.
