Re: Amending Ordinance 14-63 of the City Code to revise the All-Way Stop Intersections

Executive Summary

Staff is proposing that Council amend Ordinance 14-63 of the City Code to add or remove several all-way stop intersections that have been altered due to intersection improvements, and to correct a street name.

Discussion

Several intersection improvements have been completed resulting in changes to the all-way stop intersections. As part of periodic review of ordinances, staff is recommending these modifications to reflect actual conditions. This ordinance updates City Code to reflect these changes.

The following intersections have been altered resulting in changes to the all-way stop status:

- Construction of Dayspring Drive and Faurot Drive, signed as an all-way stop intersection
- Connection of Blue Ridge Road to Creasy Springs Road, signed as an all-way stop intersection
- Removal of all-way stop at Danforth Drive and Shepard Boulevard as part of the Shepard Boulevard and Audubon Drive traffic calming project, approved by Council on February 20, 2023
- Removal of all-way stop at Green Meadows Road and Forum Boulevard due to conversion to a roundabout in 2020
- Removal of all-way stop at Nifong Boulevard and Old Mill Creek Road due to conversion to a roundabout in 2020
- Removal of all-way stop at Nifong Boulevard and Sinclair Street due to conversion to a roundabout in 2020

This ordinance change also includes correcting the street name for the intersection of Blue Ridge Road and Oakland Gravel Road within City Code.
