2023, by and between Vicarious LLC, Missouri Limited Liability Company, hereinafter called "SELLER," and CITY OF COLUMBIA, MISSOURI, a Municipal Corporation, hereinafter called "BUYER:"

WITNESSET

H:

In consideration of the respective covenants of the parties and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned do hereby mutually agree as follows:

 That SELLER agrees to sell and BUYER agrees to buy, upon the terms and conditions herein set out, the following described property located at,307 and 309 St. James Street Columbia, Boone _County, Missouri, herein referred to as the "Property," to-wit:

33 feet off of the South side of the following described tract, a part of the Southwest Quarter (SW 1/4) of Section Seven (7), Township Forty-eight (48), Range Twelve (12), in the City of Columbia, Boone County, Missouri described as follows:

BEGINNING at a point on the East line of Survey No. 1277, the same being the Northeast corner of the tract of ground conveyed to Beverly. T. Galloway by Western Herndon by deed recorded in Book 67, Page 147, Records of Boone County, Missouri; thence South, 71.38 feet to the Northeast corner of tract of land sold to J.J. Doyle; thence West along the North side of said Doyle tract, 96.90 feet, more or less, to the East line of a tract of land sold to Estill Edwards; thence North along the East line of said Edwards property to the South line of Paris Road; thence North, 59 degrees East, along the South line of Paris Road to a point 54 links West of the point of beginning; thence East, 54 links to the POINT OF BEGINNING.

AND part of the Southwest Quarter (SW 1/4) of Section Seven (7), Township Forty-eight (48), of Range Twelve (12), in the City of Columbia, Boone County, Missouri described as follows:

BEGINNING at a point on the East line of Survey No. 1277, the same being the Northeast corner of the tract of ground conveyed to Beverly T. Galloway by Western Herndon by deed recorded in Book 67, Page 147, Records of Boone County, Missouri; thence South, 71.38 feet to the Northeast corner of tract sold to J.J. Doyle; thence West along the North side of said Doyle tract, 96.90 feet, more or less, to the East line of a tract of land sold to Estill L. Edwards; thence North along the East line of said Edwards tract to the South line of Paris Road; thence North 59 degrees East along the South line of Paris Road to a point 54 links East of the point of beginning; thence East 54 links to the POINT OF BEGINNING.

Except tract 33 feet in width north and south off of the South side thereof.

- 1. The purchase price to be paid to SELLER by BUYER for the aforesaid Property is the sum of Two Hundred Thousand Dollars, (\$200,000.00) in cash and to be paid by BUYER to SELLER at the time of closing.
- 2. SELLER shall convey to BUYER at closing by Warranty Deed fee simple absolute marketable title in fact to the above described real estate free and clear of all liens, interests, leases, restrictions, easements and encumbrances, except subject to the Permitted Exceptions referred to below herein and subject to real estate taxes for the year of closing

which shall be prorated as of the date of closing using the most current real estate tax assessment information furnished by the Boone County Assessor.

SELLER shall within fifteen (15) days hereafter deliver to BUYER a commitment to issue an owner's policy of title insurance on the real estate described in paragraph 1 above in the amount of the purchase price naming BUYER as the insured and issued by a reputable title insurance company licensed to write title insurance in Missouri, which policy shall insure the owner's title to be marketable in fact as called for by this Contract and shall provide that a policy shall be issued to BUYER immediately after the SELLER'S Warranty Deed to BUYER is placed of record. Such commitment shall be obtained through Boone-Central Title Company, Columbia, Missouri.

BUYER shall have the right to object to any matter shown in the title insurance commitment which BUYER believes may adversely affect the BUYER'S intended use of the Property by giving written notice of such to SELLER. If BUYER does not object to a matter which is shown in the title insurance commitment within twenty (20) days after BUYER receives said title insurance commitment, BUYER shall be deemed to have waived the right to object to that particular item which shall be deemed a "Permitted Exception."

If BUYER objects to a matter shown in the title insurance commitment within the aforesaid twenty (20) day period, and the defect can't be corrected by SELLER this Contract shall be null and void.

After the SELLER'S Deed has been placed of record, SELLER shall promptly procure the policy of title insurance and deliver the same to BUYER. SELLER shall pay all expenses for the title insurance, including the title insurance premium. The title insurance commitment and the title insurance policy shall include coverage against mechanic's liens and shall not exclude mechanic's lien coverage.

- 4. BUYER shall take title to the above described Property at the time of closing in its "as is" physical condition existing on the date of this Contract, except as otherwise expressly provided. Herein.
- 5. This Contract shall be closed on or before the 25th day of August, 2023, at the office of Boone-Central. Title Company, 601 East Broadway, Columbia, Missouri, or at such other time and place as the parties may mutually agree, at which time all monies and papers shall be delivered as specified herein, absolute possession of the property shall be delivered to BUYER and all other things called for by this Contract at the time of closing shall be done.
- 6. SELLER and BUYER shall each at closing pay one-half (1/2) of the closing service charge of the title company for closing services rendered in connection with the closing of this Contract. BUYER shall pay the recording fee for recording the above described Trustee's Deed.
 - 7. All notices required or permitted hereunder shall be in writing, sent to the party to whom addressed at the following address(es) and shall be deemed delivered to, and received by, the other party when (i) actually received, if hand delivered, (ii) deposited with an overnight courier, package prepaid, or (iii) placed in the United States Mail, certified letter, return receipt requested, with postage prepaid; the said address(es) being as follows:

- 9. This Contract shall be governed by the laws of the State of Missouri and the jurisdiction and venue of any dispute between the parties in regard to this transaction shall be in the Circuit Court of Boone County, Missouri.
- 10. This agreement constitutes the entire and complete agreement between the parties hereto and supersedes any prior oral or written agreement between the parties with respect to this property.
- 11. The date of this Contract shall be the date that the last party to this Contract executed this Contract.
- 12. The provisions hereof shall inure to the benefit of and shall be binding upon the respective parties hereto and to their respective heirs, personal representatives, successors and assigns.
- 13. This contract is contingent upon the formal approval of the City Council of Columbia, Missouri.
