Executive Summary

This ordinance authorizes the issuance of the Water and Electric System Revenue Bonds, Series 2023A

Discussion

This ordinance will authorize the issuance, sale and delivery of the Water and Electric System Revenue Bonds, Series 2023A for a principal amount not to exceed \$27,695,000. These bonds are for the purpose of extending, expanding, improving, repairing, replacing and equipping the City's municipal water system.

The City is expecting to receive the Standard and Poor's Bond rating on September 19th, 2023, followed by the pricing and award of the bonds by October 5th 2023. The sale and closing of the bonds is slated for October 26th, 2023.

The sale of the Water and Electric System Revenue Bonds, Series 2023A will initiated a base rate increase of \$2 for all 5/8 inch and ¾ inch meters (residential customers), all other meter types (commercial) will increase proportionally. This will take effect on the first billing cycle after the bond sale, which we anticipate will be on the November utility bill. The City Council on September 19, 2022 B217-22 (see attachment), voted to approve this rate increase.

Fiscal Impact
